Subject: Termination License to operate games of chance.

Dear Sirs,

We hereby inform you that Palmsbet Curacao B.V. (the "Company") has concluded its operation of providing online games of chance and therefore requests to terminate its license request (OGL/2024/1112/0516) for same with immediate effect.

Please note the following:

- Terminating is due to the company operating in jurisdiction/country Peru. This market is restricted and requires a local license from the authorities in Peru. For obtaining the gaming license in Peru, the shareholders have incorporated a local Peruvian company under the laws of Peru and were successful in obtaining a Peruvian Gaming License.
- Because the shareholders of company Palmsbet Curacao B.V. decided to focus first on the targeting of the Peruvian market by their Peruvian incorporated gaming company, there is currently no need for a licensed gaming company registered in Curacao. Therefore, the shareholders have decided to withdraw the request for a license from the CGA and put the operational status of the company to dormant.
- Because of the above, Palmsbet Curacao B.V. has never operated gaming services to players, therefore, there are no outstanding player claims and no deposits. The gaming domain Palmsbet Curacao B.V. intended to use for its operations was handed to the Peruvian company who have taken ownership. There were no outstanding claims at the time of handing over domain ownership.
- Additionally, we hereby confirm that Palmsbet Curacao B.V. did not have a player database
