

ADDENDUM to the Software License Agreement 20201014-001

THIS ADDENDUM has been entered into and is effective as of the 16th of October 2023 ("Effective date")

BETWEEN

IT Management Santora B.V., reg.no. 144578 ("Company"), a company incorporated under the laws of Curacao, having its registered address at Korporaalweg 10, Willemstad, Curacao,
and

Venus International B.V., reg.no. 164106 ("Partner"), a company incorporated under the laws of Curacao, having its registered address at Schottegatweg Oost 10 Unit 1-9, Bon Bini Business Center, Curacao,
Company and Partner are each individually referred to as a "Party" and collectively as "Parties".

In the scope of this Addendum the term Agreement means the countersigned Software License Agreement (Agreement), which was signed by the Parties on the 14th of October 2020.

1. Herewith the Parties have mutually agreed to make the present Addendum to the Agreement as follows:

1.1 To add the URL www.telebet724.com in definition of "Website" of clause 1 ("Terms and Definitions") of the Agreement.

1.2 Parties hereby agree that the Partner shall pay to Company the following fees for www.telebet724.com Website:

- a Set-up Fee of EUR 0 (zero).
- an integration fee of EUR 500 (five hundred) for each payment method integration and an integration fee of EUR 1000 (one thousand) for each payment gateway integration that are not integrated into the Company platform at the date of signature of this Addendum, upon the launch date of such method.
- a monthly fee of EUR 5 (five) per each additional backoffice (AGP) user's access started from the 6th user.
- a monthly Service Fee of EUR 500 (five hundred Euros) for DDoS protection service, Hosting and B2B standard support (Monthly Service Fee). In case, when the Partner does not pay the Monthly Service Fee, Company may without any prior notice, block (to blockade, to freeze) the Website for an indefinite period.
- a fixed monthly fee of EUR 1000 (one thousand) for Affiliate System started from the 4th month upon the Launch date of this product and while this product is activated on the Website.
- a fixed monthly fee of EUR 1000 (one thousand) for Agent System started from the 4th month upon the Launch date of this product and while this product is activated on the Website.
- a fixed monthly fee of EUR 1000 (one thousand) for Statistics started from the 4th month upon the Launch date of this product and while this product is activated on the Website.
- a fixed monthly fee of EUR 1000 (one thousand) for the CRM product, which includes unlimited messages, started from the 4th month upon the Launch date of this product and while this product is activated on the Website.
- a fixed monthly fee of EUR 400 (four hundred) for Live Sport Animation product started upon the Launch date of this product and while this product is provided on the website.

1.3 Parties hereby agree that the products mentioned in clause 4 ("List of Products") and commercial terms mentioned in clause 10.4 ("Revenue Sharing") of Agreement shall apply for www.telebet724.com Website.

2. Except as provided in this Addendum, all terms used in this Addendum that are not otherwise defined shall have the respective meanings ascribed to such terms in the Agreement.

3. Except as specifically modified and amended herein, all of the terms, provisions, requirements and specifications contained in the Agreement, included but not limited with the commercial terms, indicated in Clause 10 of the Agreement, remain in full force and effect. Except as otherwise expressly provided herein, the parties do not intend to, and the execution of this Addendum shall not, in any manner impair the Agreement, the purpose of this Addendum being simply to amend and ratify the Agreement, as hereby amended and ratified, and to confirm and carry forward the Agreement, as hereby amended, in full force and effect.

4. This Addendum has been duly executed in 2 (two) copies in English, one for each Party having the same force and effect.

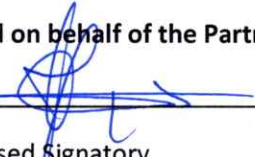
