

PRIVATE AGREEMENT

In Bulgaria, today on 27.06.2023 the following contracting parties:

- A) The Single Member Private Company named "Soft Maya LTD" with registration number 205815879 which is registered Plovdiv, 4000, Stefan Verkovich str. 10, Bulgaria

AND

- B) B)The company named "AMNM B.V", with Registration No. 159446, which is registered in Johan van Walbeeckplein 24, Willemstad, Curacao.

Were agreed upon and stipulated the following:

The first contracting company has as its object of activities – among others – the provision of software services and electronic systems, websites constructing, network technical support, manufacturing and trade of software programs and programming of electronic systems. The second contracting party has as its object of activities the acceptance and brokerage of bets and the trade of products, services etc. related to the above activity. Under the agreement hereby the first contracting party undertakes on behalf of the second contracting party:

- The analysis, design, maintenance, update and expansion of capabilities of its business software.
- Competition research in itsfield of activity.
- Statistical analysis of competition in itsfield of activity.
- Customer service by phone and text messaging (e-mail).
- Creating and editing odds.
- Provision of live streaming services.
- Provision of casino software.
- Certification of customers.
- Technical and electronic web support.
- The provision and maintenance of servers.
- The safe storage and keeping of backup copies.
- Checking the proper functioning of the web.

All these benefits will be provided for the domain:

As well as all domains that will be added and operate legally by the second contracting party, for which the first contracting party should be informed in writing and in detail.

Also any other activities not prohibited by law, with the condition that authorization or license for any relevant activity is needed, this activity will be carried out after obtaining the relevant documents, authorization or license.

The second party hereby acquires the right to use the software and services described above as long as this agreement is in force. Consequently, under no circumstances the second party acquires the right to resell the above software. It has also the obligation to maintain its source code unchanged, not distribute it in any way to third parties, and retain the right of access to the first party.

The second party is strictly prohibited to notify to third parties building instructions or copies of the contracts for the patenting of intellectual property products. By this agreement it is mutually accepted that the provided software products belong to the property of the first party. As well as all domains that will be added and operate legally by the second contracting party, for which the first contracting party should be informed in writing and in detail.

The term of the agreement hereof is set as indefinite and is considered to begin with the signing of this contract.

Termination of this contract may not take place without a 30 days prior written notice, given by the party who wishes to terminate the agreement.

The monthly fee of the first party for the construction, technical support and services provided to the second party shall be set at the rate agreed between the two parties, to be paid within the first five (5) days of each month, upon issuance of the relevant invoice. For any additional order or request, pricing and payment of the additional fee will be made, depending on the nature and the subject of activity.

For the purposes of the present agreement, the first party shall employ the appropriate staff during the working days and hours.

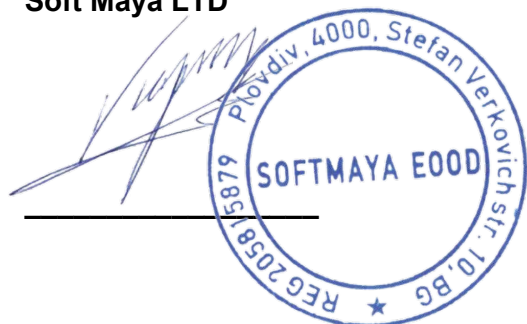
Soft Maya LTD has the sole responsibility for its actions only and not for the actions of the second party.

Any violation of the terms of the agreement hereof will constitute a reason of its termination on behalf of the innocent contracting party and result penalty forfeiture against is to the amount of 22.000,00 Euro in the offender's name.

Any dispute that may arise from the interpretation and execution of the agreement hereof will be subject to the jurisdiction of the courts of Bulgaria.

The agreement hereby is signed in two identical copies, one per each contracting party.
