3) Declaration

I, the undersigned, hereby certify and declare that the operations of AMNM B.V. are fully funded and maintained in their entirety by me, Ioannis Kaisarios. This includes all corporate operating expenses and working capital requirements needed for the lawful operation of the business.

Funds utilized for the Company's obligations derive from personal investments made in prior years, including holdings of digital assets (cryptocurrencies) maintained by me in a self-custodied cold wallet.

Where conversions to FIAT are required, I utilize regulated third-party exchanges and/or licensed payment service providers (PSPs). Where appropriate, I may also settle certain Company obligations directly in cryptocurrency. The Company itself does not provide currency exchange or conversion services to any third party or customers; all conversions occur off-platform via regulated institutions.

All funds are legitimate, verifiable, and available to support ongoing operations of the Company.

- Crypto evidence: wallet addresses (cold storage), signed message or other proof of control, exchange account balance/transaction statements, and FIAT conversion records.
- Any additional documents requested by the GCB to corroborate the above.

The funds provided to the Company are not the proceeds of criminal activity, have been subject to appropriate due diligence, and can be traced to lawful sources. I consent to the Curaçao GCB conducting enhanced due diligence and to the verification of the enclosed documentation with the issuing institutions.

6) Clarification Regarding Crypto Funds & Wallets

The Declarant maintains digital asset holdings in a personal, self-custodied cold wallet stemming from past investments. For operational purposes, when required, digital assets are converted into FIAT through regulated exchanges or licensed payment service providers (PSPs), or used to settle obligations directly in cryptocurrency where appropriate. The Company does not itself provide exchange or conversion services.

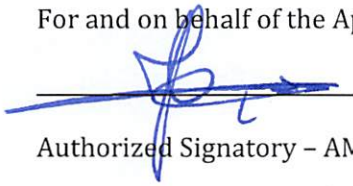
