

ADDENDUM No. 1

to the Paying Agent Agreement dated on the 11th of April 2023

THIS ADDENDUM is made on the 1st of November 2024 (the "**Addendum**"),

BY AND BETWEEN:

- 1) **MEDIAL N.V.**, a company duly registered and incorporated under the laws of Curacao with registration number 156005 having its registered address Zuikertuintjeweg z/n, Willemstad, Curacao (hereinafter the "**Principal**"); and
- 2) **CHITIEN LTD**, a company duly registered and incorporated under the laws of the Republic of Cyprus with registration number HE 421174, having its registered address at 56 Alekou Konstantinou, 2024, Nicosia, Cyprus (the "**Paying Agent**").

The Principal and the Paying Agent shall be hereto collectively referred to as the "**Parties**".

RECITALS:

WHEREAS the Parties have entered into a Paying Agent Agreement on the 11th of April 2023, whereby the Principal has appointed the Paying Agent to receive funds on its behalf, complete foreign exchange transactions and transfer the received funds to the Principal (the "**Paying Agent Agreement**").

WHEREAS the Parties hereby wish to amend paragraph A of the Paying Agent Agreement and in this respect, it is proposed that the Parties enter into this Addendum, on or around the date hereto.

IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:

1. To amend paragraph A of the Paying Agent Agreement as follows:

"The Principal has been issued an online gambling/gaming license by the Curacao Gaming Control Board (GCB) with License Number: OGL/2023/115/0092 (the "Gaming License"), in order to provide games of chance, to engage in and offer gaming services."

2. This Addendum shall form an integral part of the Paying Agent Agreement and shall be read and construed together.
3. The present Addendum does not affect by any means any other agreements or any other term or condition of the Paying Agent Agreement except as stated hereinabove.
4. This Addendum shall enter into force on the date thereof, as signed by the authorized representatives of the Parties hereunder.

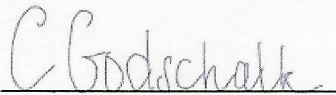

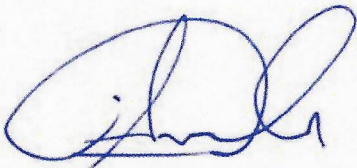
