Company

IOGr B.V., a limited liability company incorporated and existing under the laws of Curaçao, with its registered office at Chuchubiweg 17, Curaçao, registered with the Curaçao Chamber of Commerce under number 161532 (the “Company”).

Declaration

I, the undersigned, Vladislav Kropachev, hereby solemnly and truthfully declare and confirm as follows:

1. **Provision of funds.** I have made available, and continue to make available, financing to the Company in an aggregate amount of up to EUR 300,000 (three hundred thousand euro), pursuant to the Shareholder Loan Agreement entered into between myself as Lender and the Company as Borrower on 4 March 2026 (the “Loan Agreement”). The funds are advanced in one or more installments by bank transfer or other lawful payment methods.
2. **Ownership of funds.** The funds advanced and to be advanced under the Loan Agreement are my own personal funds. They are legally owned and controlled by me, are free of any third-party claims or encumbrances, and are not held or advanced on behalf of any other person or entity.
3. **Availability of funds.** I confirm that I possess, and have at my disposal, sufficient personal financial means to fund the full amount of the Loan. Supporting evidence of the availability of these funds (including bank statements and other financial documentation) can be provided upon request.
4. **Use of funds.** The funds are provided to, and are used by, the Company exclusively for its general corporate purposes, including the establishment and operation of the Company, licensing and regulatory compliance (including before the Curaçao Gaming Authority), working capital requirements, and the Company’s ongoing business activities. Where I incur expenditure personally on behalf of the Company, such expenditure is made from my own funds and solely in the interests and for the purposes of the Company.
5. **Lawful origin.** The funds originate exclusively from lawful sources and are in no way derived from, or connected with, any criminal or unlawful activity, money laundering, terrorist financing, or breach of applicable sanctions.
6. **Source of the funds.** The funds advanced under the Loan Agreement derive from my personal employment income (salary), lawfully earned and accumulated by me

over the course of my professional career. Supporting documentation evidencing this source — including employment contract(s), salary statements, bank statements, and tax documentation — can be provided upon request.

7. **Cooperation.** I undertake to provide, promptly upon request, any supporting documentation regarding the origin and availability of the funds to the Company, the Curaçao Gaming Authority, financial institutions, auditors, or any other competent authority.
8. **Accuracy.** The information set out in this Declaration is true, accurate, and complete to the best of my knowledge and belief. I undertake to notify the Company without delay of any material change to the information contained herein.
