Terms and Conditions

1. Loan Provision:

2. The UBO, **Byungoh Min**, hereby agrees to provide an interest-free loan of EUR **100,000.00** (the "Loan") to **Sunrise Worldwide Solution N.V.** (the "Company").

3. Loan Nature:

- a. The Loan shall bear a fixed interest rate of 5.0% per annum.
- b. Interest shall accrue annually on the outstanding principal balance, calculated on a simple interest basis (i.e., without compounding).
- c. Interest shall be payable together with each principal repayment.

4. Repayment Terms:

- a. The Company shall repay the Loan in full, including accrued interest, on or before **30th May 2027** (the "Repayment Date").
- b. Repayment shall be made in a single installment of EUR **20,000.00**, beginning on **30th May, 2026**.
- c. Repayment may be made via bank transfer or other agreed methods, details of which shall be provided by the UBO.
- d. Early repayment of the Loan, either in full or in part, shall be permitted without penalty.

- b. They have entered into this Agreement voluntarily and without any form of coercion or undue influence.

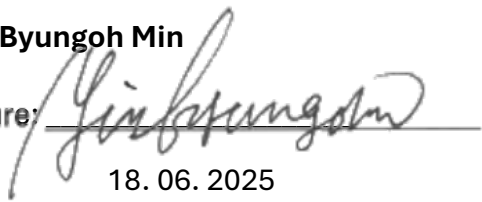

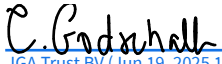
