## Section 1: Executive Summary

Enetpulse and SportRadar have been our partners for many years and provide us with all the necessary data in this area.

PlanetOfBets also has unique system for visualizing events that occur on the fields of matches in the main sports. This visualization system is also own development, which has no analogues and is used for most matches on which bets are accepted in Live mode. In cooperation with such companies as Evolution Gamings, SoftGamings and Slotegrator PlanetOfBets provides the service of Live casino, slots and virtual sports on planetofbets.com. These sections of the site include the main providers in this area, the list of which is constantly updated and changed, in accordance with the requirements of the users and the realities of the market. That is the list is constantly being adapted and always gives actual information about the providers that are popular in certain regions of PlanetOfBets' work.

PlanetOfBets team of analysts is constantly developing and implementing new bonus programs that are aimed at maintaining the activity of our clients, as well as attracting new players. It is worth noting that some of our bonus programs are also unique and have no analogues on the market.

## Section 5: Strategy for the business growth

Based on the statistics of recent years it's expected that gambling services market will continue to grow. PlanetOfBets is planning to develop, increase turnover and profits by implementing:

1. New bonus programs for existing users. Analyzing the user's betting characteristics using AI, PlanetOfBets offers users individual bonus programs that maintain interest to our services. Since bonus programs are selected individually for the users it takes into account all the user's betting characteristics and in 90 percent of cases are approved by the user and such strategy eliminates the desire to change the service provider.

2. New bonus programs for new users. PlanetOfBets always analyzes the maximum information about the bonus programs of competitors, as a result of which we provide competitive and interesting offers for new users.

3. Addition of new slot and casino providers. Based on reality the list of providers is constantly changing and expanding. Users' requests change, the popularity of providers in different countries of the world changes, so PlanetOfBets are constantly working with the partners to expand the list of casino and slot providers that are presented on our website.

4. Adding new payment systems and cryptocurrencies. Based on the characteristics of the market PlanetOfBets constantly analyzes new payment systems that operate in this area, as well as analyzes cryptocurrencies that are gaining popularity in the world. Expanding the list of payment methods available for deposits always remains priority for PlanetOfBets.

5. Conducting marketing campaigns on target services such as the LiveScore website, thematic forms, thematic channels of video services. PlanetOfBets constantly places advertisements in various services that are somehow involved in this area.

6. Constant active work with users allows to PlanetOfBets to satisfy the wishes of the most demanding users. The statistics shows that a very large number of users of PlanetOfBets have been working with us for 4 years or more. It indicates that users are completely satisfied with the level of service of PlanetOfBets. Therefore, PlanetOfBets will definitely continue to work with the wishes of the users.

## **Section 6: Risk evaluation and management**

The risks affecting PlanetOfBets performance and ability to deliver on its key performance indicators are best categorized into external and internal risks.

### **External Risks**

As it was indicated above PlanetOfBets is developer and owner of unique software and platform that requires serious protection and technical equipment to operate permanently.

PlanetOfBets works with the world's leading data centers such as OVH and Hetzner and DDoS attack protection system - CloudFlare. In cooperation with these companies PlanetOfBets technical specialists maintained the uptime of the services at 99.9% level for many years. It is one of the best level in the market.

PlanetOfBets entire infrastructure is built according to the most modern standards. Constant system updates, training of specialists in advanced training courses, as well as timely replacement of equipment, allow us to maintain such a high level of service. The security of data transmission from users to PlanetOfBets servers is protected by SSL certificates from world leaders such as GeoTrust and DigiCert.

Given the specificity of this area PlanetOfBets also constantly working on our AML policy, Privacy policy and Responsible game. PlanetOfBets specialists are constantly undergoing training at specialized advanced training courses, to be ready for any new challenges and prevent any illegal activity. In cooperation with payment systems PlanetOfBets constantly monitor all movements of funds and instantly block any illegal or suspicious activity through our service. In the field of cryptocurrency payments PlanetOfBets uses the services of world leaders to check payments and payouts for all types of cryptocurrencies. All cryptocurrency transfers that have high risk levels are blocked.

### **Internal Risks**

PlanetOfBets attracts first-class specialists from worldwide and as result operates in online model of work. Such model can create internal risks related to employee performance, training, satisfaction, retention, and communication. To help with this such issue PlanetOfBets completed a full cloud platform to communicate and control all specialists. PlanetOfBets uses in-person events such everyday online meetings, discussions, multi recipients correspondence, monthly management meetings, and regular touchpoint meetings to ensure proper communications both between and within departments. All measures help to minimize the risks repated to employee efficiency and effectiveness but also addresses any issues head on.

## Section 7: Legal and governance framework

Management of PlanetOfBets is borne Management director, the company Downtown E-Commerce Company B.V. which was appointed by sole UBO of PlanetOfBets.

Management director is responsible for accounting, corporate secretarial, legal and other services as from time to time specifically requested by PlanetOfBets. Management director follows the instructions of PlanetOfBets UBO. At the same time Management director as resident of Curacao is unconditionally authorized to take any action, without any further authorization or instructions from PlanetOfBets in order to keep PlanetOfBets in compliance with the laws, rules and regulations of Curacao.

## Section 8: Target KPIs and business objectives

For the 2025-2027 fiscal years and beyond PlanetOfBets identified five key performance indicators (KPIs) to measure the performance of the organization:

1. Increase the number of users by 25% through advertising, new bonus programs for new users and improved service quality.
2. Achieve net profit growth 15% per year by increasing of users and optimizing of the expenses.
3. Increase PlanetOfBets staff by 10% by new highly qualified specialists with new knowledge and ideas.
4. Achieve the partners satisfaction target of 100%. PlanetOfBets set a base target of 90% of the partners and specialists recommending PlanetOfBets cooperation. PlanetOfBets makes every effort to increase partners and specialists' satisfaction and improve efficiency by optimizing work patterns and its results for both parties.
5. Reduce data processing time and technical support response time by 30% by improving equipment and staff professionalism.

These KPIs and business objectives were chosen reflect the priorities of PlanetOfBets management and shareholders.

## Section 9: Policies and Procedures

PlanetOfBets is very sensitive to all the requirements of legislation and rules in the gaming industry, therefore a number of documents have been developed that are always available on the website for all users in a few languages. Given the specificity of this area PlanetOfBets constantly improving the documents. PlanetOfBets specialists are constantly undergoing training at specialized advanced training courses to be ready for any new challenges and to prevent any illegal activity.

# Appendix 1

## AML Policy

### 1. Definitions:

Account – the Client's account created after registration on the Company's website.

Client – an individual who is fully capable in accordance with the law of his country of residence and has registered on the Company's website.

Company – the company Planet of Bets Entertainment B.V. (registration number: 133510), registered at: Zuikertuintjeweg Z/N Zuikertuin Tower, Curacao.

Deposit – the amount of fund deposited by the Client on his Account's balance to place the bets.

Winning – the amount of funds (electronic funds) to be paid (increase of the Account balance) to the Client if the bet has won.

2. Any criminal or fraudulent activity is prohibited and may lead to Client's account being blocked and all the funds will be frozen.

The Company will seek criminal and civil sanctions against any Client involved in fraud and other criminal acts.

### 3. Fraud may include:

- payment to the Account using someone else's bank card or voucher;
- use of another's account in the electronic payment system;
- any collusion between the Clients;
- use of false personal information for the Account registration;
- any documents forgery.

Any action can be regarded as criminal if it violates the laws of the Client's country or other countries.

4. We reserve the right to verify history of the origin funds in the Account balance. As well as the right to request additional information necessary to verify the history of the origin funds.

5. To analyze and identify any illegal activity we will use the following actions:

- imposing restrictions on the payment of Winnings and withdrawal of funds;

- additional verification of all transactions exceeding 5000 USD;
  - monitoring and blocking the opening of paired Accounts;
  - saving of total history of the Client's Account, including the Client's personal data, the dates and times of logins to the Account, the IP address of the logins to the Account, numbers of payment documents that were used for the Deposit or payment.
6. We have the right to decide to close the Client's Account when there is a suspicion of involvement in illegal activities. The Account can be closed until end of the respective investigation.
7. Every case of fraud or other criminal actions can be sent by us to the supervisory and other law enforcement agencies, thus we provide them with access to all Account information for further investigation and final decision.
8. The Account belongs to the person of its owner and is not transferable to another person. Transfer of the Account to another person will be considered as violation of the Terms and conditions and may lead to the Account closing with frozen of the balance.
9. We reserve the right to verify the Clients's gaming activity. Standard time for this verification is 3 (three) working days. At this time processing with the payments on the Account will be suspended.

## Appendix 2

### Privacy Policy

#### General terms

This Privacy Policy applies to the websites of PlanetOfBets group (the “Site”) owned by Planet of Bets Entertainment B.V. (Zuikertuintjeweg Z/N Zuikertuin Tower, Curacao) (hereinafter - the "Company").

This policy defines how we collect and use the personal data which you provide on the Site, and also describes the actions you can take regarding our use of your personal data, and explains how you can access and update this information.

The Company reserves the right to make changes to this Privacy Policy without the consent and notification of users.

#### Cookie files

The site and all applications use cookie files. Cookie files are small files that are downloaded to your computer and help ensure correct functioning of the website, as well as help in administration login sessions, presenting personalized web pages and selecting content that reflects your specific needs and interests, collecting statistical data to improve the service provided. Some cookie files are temporary and will be deleted after closing the browser window, some are permanent and stored for a longer time. Agreement to use cookie files in the appropriate pop-up window on our Site you agree to use cookie files and similar technologies for the purposes described in this policy.

The Site uses Google Analytics, a website analysis service from Google Inc., as well as Google's user-recognition system reCaptcha.

Some sections of our website, namely: Live-casino, slots and virtual sports provide services in conjunction with our partners who can also use cookie files, whose usage policies are defined on the partners' websites.

You can disable using of cookie files at any time or configure your web browser to warn you when such files are received. However if cookie files are turned off some of the functions of our website may not work or work incorrectly. For correct working of all sections and functions of our website cookie files must be allowed without restrictions.

#### Personal data which we collect

Navigation through the Site does not require entering any personal data until you decide to use the products presented on the Site. Starting of the products using intends the registration of the user in the system with providing of the personal data.

For registration as user you must provide following information:

1. First Name, Surname
2. Home address, city and country of residence, zip code

3. Date of birth
4. Telephone number
5. Email
6. Proof of 18 years old

When you make financial transactions the Company has the right to request a copy of your identity document.

When you visit the Site, even if you do not register, we may collect certain data such as IP address, type of browser used, information about the computer's operation system, application version, language settings and displayed pages. If this data can allow to identify you as an individual this data is considered personal data covered by this Privacy Policy.

As registered user you may to change or correct your personal data in any time except first name, surname, date of birth and country of residence. The changes can be made in the section “Profile” of the Site’s main menu.

### **Prevention access for underage**

Persons under the age of 18 are prohibited from using the products presented on the Site. For this during registration we necessarily request the information about the date of birth and confirmation of majority reach.

In addition the Company is entitled to request a copy of an identity document. Wherein if we find out that you have not reached the age of majority but during registration indicated false data, then all operations on your account will be subject to the principle of retroactivity regardless of whether they were winning or losing. In this case the user's gaming account will be blocked without the possibility of renewal.

### **Using of your data**

Your personal data specified during registration and updated upon further using of the Company’s products are stored using the Company's technical instruments and are not transferable, are not sold and are not provided for temporary use to third parties.

Your personal data will be used only when permitted by law. As a rule your personal data will be used in the following cases:

- In purpose to fulfill obligations within framework of the Company’s services providing;
- In purpose to respect the legitimate interests of the Company (or the interests of third parties) and to ensure that your interests and fundamental rights do not prevail over these interests;
- In purpose to fulfill legal or regulatory obligations (including but not limited providing this information to the competent authorities in the event that the Company receives corresponding official request or cases of fraud from your part).

By providing personal data and registering on the Site you give us the consent for processing and disclosing your personal information in the manner specified in this Privacy Policy or as provided in the Terms and Conditions.

In case of suspicious behavior your personal data can be checked with the data of your provider. In the event of fraud in the area of betting, game manipulation as well as actions that lead to intentional violation of the

Company's services the Company reserves the right to transfer your data to sports communities, authorities and other third parties investigating such suspicions.

If you want to close a gaming account keep in mind that in order to preserve the integrity of the database your personal data continues to store in the system and protected as if you continued to use your account.

The Site may contain links to websites, plug-ins and third-party applications. Clicking on such links or activating such connections may allow third parties to collect or transmit your data. The Company does not control and is not responsible for the privacy statements of such third party websites. When you leave our website, the Company recommends you to read the notes about confidentiality of all Internet resources that you visit.

## **Security measures to protect your data**

The Company guarantees that your personal data:

- are processed in accordance with your rights;
- are processed fairly and lawfully;
- are collected only for aforecited purposes;
- are collected properly and in the required volume in terms of the goal;
- are stored in compliance with all necessary security measures;
- are not stored longer than necessary for specific purposes.

The Company undertakes and constantly improves measures to protect your data during using products on the Site.

- A security certificate from world name company providing secure data transfer from the user's computer to the Company's server;
- Recording of IP addresses of all computers appealed to the bet line;
- Protection of the Company's internal network from unauthorized access by third parties;
- We use own hardware and software systems and protection from world name developers.

## **How long we keep the personal data**

Personal data will be kept in our system for the minimum period of time required to comply with the Company's legal, financial and regulatory requirements.

The term of keeping will be determined by the current requirements of Curaçao law (minimum 10 years).

### SAFER GAMBLING POLICY

#### General terms

This Safer Gambling Policy applies to the websites of PlanetOfBets group (the “Site”) owned by Planet of Bets Entertainment B.V. (Zuikertuintjeweg Z/N Zuikertuin Tower, Curacao) (hereinafter - the "Company").

The Company is aware that most people gamble for fun but there is a group of people who can become obsessed with the game. The Company takes this issue extremely seriously and responsibly.

The Company reserves the right to make changes to this Safer Gambling Policy without the consent and notification of users.

#### Prevention access for underage

Persons under the age of 18 are prohibited from using the products presented on the Site. For this during registration we necessarily request the information about the date of birth and confirmation of majority reach.

In addition the Company is entitled to request a copy of an identity document. Wherein if we find out that you have not reached the age of majority but during registration indicated false data, then all operations on your account will be subject to the principle of retroactivity regardless of whether they were winning or losing. In this case the user's gaming account will be blocked without the possibility of renewal.

#### Using of your data

Your personal data specified during registration and updated upon further using of the Company's products are stored using the Company's technical instruments and are not transferable, are not sold and are not provided for temporary use to third parties.

Your personal data will be used only in cases permitted by law.

#### The Site Tools

The Company has developed special tools and functions that can make your game safer:

- You can track your activity on the Site and calculate the amount of time and money spent on the betting;
- You can use self-exclusion mode. At your request we will delete your account on the Site and will not allow you to log in again.

## RECOMMENDATIONS

- Make sure that the decision to bet is your conscious choice;
- Make sure you know the rules of the gambling;
- Gambling is a form of entertainment, a hobby. This is not a get-rich-quick scheme;
- Gambling is a game of chance, there are no formulas that guarantee winning;
- Spend only the amount that will not jeopardize your ability to pay;
- Keep track of the time spent on the Site;
- Regularly check the amount you spend on the betting;
- Never make bets under the influence of emotions, you must clearly understand why you made each bet and how much you are ready to bet;
- Do not place bets while under the influence of alcohol, drugs or depression;
- Take regular breaks in betting and set a time limit for the gambling;
- Do not make hasty decisions;
- Do not put the gambling above family, friends or work;
- If you feel that you cannot stop betting please contact us to freeze your account or use the self-exclusion mode and visit therapist immediately.

### Gambling addiction

Gambling addiction is the result of extreme gambling behavior that can lead to serious problems in every aspect of your life.

The main signs of gambling addiction are:

- You spend a lot of time on the game;
- You spend huge sums of money that cause significant damage to your budget;
- Bets are more important to you than family and/or friends;
- You are only interested in gambling and other hobbies no longer attract you;
- You can't stop thinking about the game and bets;
- You hide your hobby from your closest people;
- You put your bets above work because in your opinion this is an easier way to earn money;
- You always try to win back and do not lose;
- You borrow money to place the bets;
- After the next loss you swear to yourself that you will not make any more bets in your life;
- You always feel the need to be in the game to feel positive emotions.

**Be attentive to yourself and remember that the Company is always ready to help you and the Site has a self-exclusion mode that you can use as soon as you notice problems.**
