

ADDENDUM №5

to the

Software License and Service Agreement

dated 26th day of April 2024

CONCLUDED BETWEEN

GREEN PLATFORM N.V. and BAMLA LIMITED N.V. (the “Agreement”)

by and between:

Green Platform N.V., a Curacao company, having its business address at Groot Kwartierweg 10 Livestrong Building, Curaçao and company registration number 162074 (“**Licensor**”)

and

Bamla Limited N.V., a Curacao company, having its business address at 1 Abraham de Veerstraat, Willemstad, Curaçao and company registration no. 164689 (“**Licensee**”), together referred to as “the Parties”.

AGREED AS FOLLOWS:

1. The Parties to the Agreement enter into this Addendum №5 in order to expressly agree to amend the Agreement by way of adding new Licensee’s Website, therefore update Annex B and stipulate the following:

“**Appendix B**

2. The Parties confirm and agreed that all Game Provider fees, revenue shares, pricing, commercial terms, and payment conditions applicable to the Licensee under the Agreement with respect to the website <https://www.rioplay.com> shall apply identically to the new website added under this Addendum.
3. At the same time, the Parties expressly agree that Appendix A (37) shall not apply to the new website and shall remain applicable only to the <https://www.rioplay.com> website, unless otherwise agreed in writing.
4. The Parties agreed that the minimum monthly fees under the Agreement shall be calculated on a consolidated basis for both websites together and shall not be applied separately to each website.
5. The Parties agree to amend section “Definitions and Interpretation” of the Agreement with the following:
“

‘Gaming Revenue’ means the total sum aggregated from revenues generated via the Software from every use of the Games. GGR shall refer to Gross Gaming Revenue and NGR to Net Gaming Revenue.

or **‘GGR’ / ‘NGR’**

*GGR shall be calculated as: gross monies received as Players wagers by the Licensee from any use of the Games (**‘Total bets’**), less monies paid out as winnings of Players (**‘Total wins’**) in Respective Period ($GGR = Total\ bets - Total\ wins$), as reflected for each reporting Website, Game Provider and category separately;*

”

6. The Parties agreed to amend the Agreement by way of updating GGR calculation logic related to negative amount, therefore stipulate the respective part of Appendix A “Games and Fees General Conditions” with the following:

“Appendix A

Games and Fees
General Conditions

[...]

If the GGR for a month is a negative amount, it shall be deemed zero, that negative amount may not be carried over to a subsequent month, nor offset against the results of any other Game Provider, game category, or Website.

7. Unless explicitly provided otherwise in this Addendum, all defined terms herein shall have the same meanings ascribed thereto in the Agreement.
8. For the avoidance of doubt, it is hereby clarified that the amendments above shall be incorporated into the Agreement and shall constitute an integral part thereof. It is further clarified that the Agreement shall be modified only as explicitly specified above and all the other terms and conditions of the Agreement shall remain unchanged and in full force and effect. In the event of any inconsistency between the terms of the Agreement and the herein Addendum, the terms of the herein Addendum shall govern and be paramount.
9. This Addendum, together with the Agreement and any documents referred to in it, constitutes the entire agreement between the Parties with respect to its subject matter and supersedes and extinguishes any prior drafts, agreements, undertakings, representations, warranties and arrangements of any nature and may not be modified except by an instrument in writing signed by the duly authorized representatives of the Parties.
10. The Effective Date of this Addendum №5 shall be considered as of January 24, 2026 (“Effective Date”).

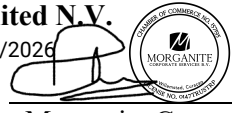
