Dear Sirs,

We hereby inform you that the Board of Directors of **Red Digital N.V.**, a limited liability company established in Curaçao and registered under number **159202** at the Curaçao Chamber of Commerce and Industry, has resolved to discontinue and withdraw the online gaming license granted by your Authority on **December 16, 2024** under reference number **OGL/2024/1275/0771**.

As part of the Company's winding-down process, all pending withdrawal requests have been cleared and paid to the relevant players, and no withdrawals remain outstanding. Players may still contact us via the relevant support email address to request payment of their balances, providing up-to-date KYC documentation and proof of payment account ownership. Payments will then be processed via the relevant PSP. Please note that the Company is discontinuing its business operations, the transfer of the players database is not applicable.

We respectfully request that you update your records to reflect this withdrawal and consider this communication as formal notice of the termination of the license of Red Digital N.V. with the Curaçao Gaming Authority.

WHEREAS the Company submitted an online gaming application on the 4th of April 2024, with reference number OGL/2024/1275/0771, at the Curaçao Gaming Authority, which currently has its registered office at Scharlooweg 172-174, Curaçao (hereinafter referred to as the “CGA”);

WHEREAS on the December 16, 2024, the Company was granted the license to offer games of chance under license number OGL/2024/1275/0771 in accordance with the National Ordinance on Offshore Games of Hazard;

WHEREAS after careful evaluation of the market and the Company’s strategic direction, the Company has determined that it will not pursue this type of business anymore;

WHEREAS the Company shall discontinue and withdraw its license from the CGA;

WHEREAS the Managing Director believes that withdrawing the license from the CGA is in the best interest of the Company.

DO HEREBY ADOPT the following resolutions:

1. To approve and ratify the decision to withdraw the license granted on the December 16, 2024, by the CGA, with license number OGL/2024/1275/0771.
2. To ratify all actions taken and/or documents signed, sealed or otherwise executed and delivered in relation to the discontinuation of the application process with the CGA.

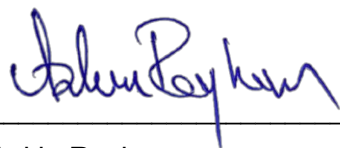
