Subject: Declaration Tax Good Standing 130Group N.V.

Dear Sir/Madam,

IGA Trust B.V., as Director of 130Group N.V., hereby acknowledges that the company has not yet obtained the required certificate from the Tax Authorities (Verklaring Betalingsgedrag) due to pending claims. We confirm that the company is actively pursuing the certificate and remains fully compliant to the best of our knowledge.

Accordingly, we declare:

1. As far as our records indicate, 130Group N.V. is in good standing and continues to meet its corporate obligations.
2. With respect to the tax position of the company, we confirm that any outstanding tax debts have been formally objected to on July 3, 2025.
3. The fine issued by the Tax Authorities relate to the Profit Tax of year 2022 and the Sales Tax of June 2024. We believe there are justifiable grounds for objection, given that:
 - a. Profit Tax of Year 2022: although the return was submitted late on September 17, 2024, the taxable amount is 0.
 - b. Sales Tax of June 2024: although the return was submitted late on August 19, 2024, the taxable amount is 0.
 - c. There is no history of prior fines. Thus, the assessments/demand notes are expected to be reduced to only the fine for late submission.
4. In our considered opinion, these disputed matters should not hinder or delay the processing of the company's license application with the Curaçao Gaming Authority.
