

First Addendum to Software Licensing and Services Agreement

This addendum has been entered into on 1 December 2022 (the "**Effective Date**")

BETWEEN

Of the first Part,

Gammix STS B.V., a company incorporated and registered under the company registration number **132869** and having its registered address at **Fransche Bloemweg 4, Willemstad, Curaçao** (hereinafter referred to as the "**Company**");

AND

Of the second part

Mirage Corporation N.V., a company incorporated and registered under the company registration number **147011** and having its registered address at **Fransche Bloemweg 4, Willemstad, Curacao** (hereinafter referred to as the "**Licensee**").

(the Company and the Licensee shall together be referred to as the "**Parties**")

Definitions

In this Addendum, the following terms shall have the meanings given to them hereunder:

1. The "**Addendum**" means this present addendum, which shall be construed as forming an integral part of the Agreement signed by the Parties;
2. The "**Agreement**" means the Software Licensing and Services Agreement entered into by the Parties on 12 January 2021;
3. The "**Games**" shall have the same meaning given in the Agreement;
4. The "**Licensed Software**" shall have the same meaning given in the Agreement;
5. The "**New Games**" means the new games that shall be added to the Licensed Software by means of the present Addendum;
6. Other terms used in this Addendum shall have the same meaning given in the Agreement.

Preambles

- (A) **WHEREAS** on 12 January 2021 (the "**Date of Agreement**"), the Parties entered into the Agreement by means of which the Company granted to the Licensee, who accepted, a license to make use of the Licensed Software, including the Games, under the terms and conditions set forth in the Agreement;
- (B) **WHEREAS** following the Date of Agreement, the Company has entered into further agreements with Games Providers in terms of which the Company acquired the right to, inter alia, sub-license the New Games to the Licensee;
- (C) **WHEREAS** following the Date of Agreement, the Company and the Licensee have entered into negotiations to amend certain fees as defined in the Agreement;

- (D) **WHEREAS** the Licensee has requested the Company, who accepts, that the New Games shall be added to the Licensed Software and to amend certain fees, and the Parties have therefore agreed to enter into this Addendum to add the New Games to the Licensed Software and to incorporate the amended fees into the Agreement.

NOW THEREFORE, the Parties have agreed:

1. The table in Paragraph (ii) of Section B of Appendix III of the Agreement shall be amended to read and substituted in its entirety by the following:

2. The list in Paragraph (iii) of Section B of Appendix III of the Agreement shall be amended to read and substituted in its entirety by the following:
- **Casino Hold'em Fee:** A fee of one per cent (1%) of the Gross Gaming Revenues generated through any Casino Hold'em table;
 - **Special Tables and Side Bets Fee:** Some games and side bets shall be provided at a fee of three per cent (3%) of the Gross Gaming Revenues (such as, but not limited to, Blackjack 21+3, Blackjack PP, Blackjack PP2, Buster Blackjack, Caribbean SP, Double Ball Roulette, Extreme Texas Hold'em, Lightning Roulette, Perfect Pair, Progressive Blackjack, Three Card Poker, Top 3);
 - **Game Shows Tables Fee:** A fee of five per cent (5%) of the Gross Gaming Revenues generated through some Game Shows tables;
 - **High Stakes Fees:** A fee of EUR thirty-five cents (€0.35) per bet placed by a Player on High Stake tables;
 - **Evolution Blackjack Growth Table Fees** (part of the Generic Tables offering for Blackjack): A fee of EUR fifteen cents (€0.15) per bet placed by a Player on a Blackjack Growth table;
 - **Playtech Low Limit Blackjack Table Fees:** A fee of EUR ten cents (€0.10) per bet placed by a Player on a Low Limit Blackjack table;
 - **Betsoft Jackpot Handling Fee:** A fee in the amount of twenty per cent (20%) of Jackpot Contributions;
 - **Playtech Jackpot Handling Fee:** A fee in the amount of ten per cent (10%) of Jackpot Contributions;
 - **BetConstruct Branded Live Blackjack Fee:** A Fee of EUR seven cents (€0.07) per bet placed by a Player on a CreedRoomz Branded Live Blackjack table;
 - **BetConstruct Branded Live Casino Fee:** A fee of three per cent (3%) of the Gross Gaming Revenues generated through Branded Live Casino tables (such as, but not limited to, CreedRoomz Branded Aurum Roulette table).
3. The remaining provisions of Section B of Appendix III of the Agreement shall remain unamended.
4. The amendments provided in this Addendum shall come into force from the Effective Date, subject to the same terms and conditions of the Agreement.
5. The Parties hereby declare that apart from the amendments to the Agreement as provided in this Addendum, the Agreement, as possibly amended from time to time, shall remain in full force and shall have full effect with regard to all other clauses previously agreed to in the Agreement.

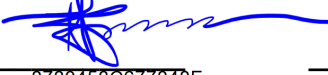
