I, Claire Godschalk, in my capacity as Director of Platinum Technology N.V. hereby acknowledge that the company has not yet obtained the required certificate from the Tax Authorities (Verklaring Betalingsgedrag) due to pending claims. I confirm that the company is actively pursuing the certificate and remains fully compliant to the best of our knowledge.

Accordingly, I declare:

1. As far as our records indicate, **Platinum Technology N.V.** is in good standing and continues to meet its corporate obligations.
2. With respect to the tax position of the company, I confirm that any outstanding tax debts have been **formally objected to on July 17, 2025.**
3. The fine issued by the Tax Authorities relate **late filing.** We believe there are justifiable grounds for objection, given that no amounts were reported and there is no history of prior fines. Accordingly, the penalty is expected to be reduced to zero.
4. In our considered opinion, these disputed matters should not hinder nor delay the processing of the company's license application with the Curaçao Gaming Authority.
