

Second Addendum to Software Licensing and Services Agreement

This addendum has been entered into on 13 June 2023

BETWEEN

Of the first Part,

Gammix STS B.V., a company incorporated and registered under the company registration number **125471** and having its registered address at **Fransche Bloemweg 4, Willemstad, Curacao** (hereinafter referred to as the "**Company**");

AND

Of the second part

Versus Odds B.V., a company incorporated and registered under the company registration number **147011** and having its registered address at **Fransche Bloemweg 4, Willemstad, Curacao** (hereinafter referred to as the "**Licensee**").

(the Company and the Licensee shall together be referred to as the "**Parties**")

Definitions

In this Addendum, the following terms shall have the meanings given to them hereunder:

1. The "**Addendum**" means this present addendum, which shall be construed as forming an integral part of the Agreement signed by the Parties;
2. The "**Agreement**" means the Software Licensing and Services Agreement entered into by the Parties on 12 January 2021;
3. The "**Effective Date**" shall mean 11 April 2023;
4. The "**Games**" shall have the same meaning given in the Agreement;
5. The "**Licensed Software**" shall have the same meaning given in the Agreement;
6. The "**New Games**" means the new games that shall be added to the Licensed Software by means of the present Addendum;
7. Other terms used in this Addendum shall have the same meaning given in the Agreement.

Preambles

- (A) **WHEREAS** on 12 January 2021 (the "**Date of Agreement**"), the Parties entered into the Agreement by means of which the Company granted to the Licensee, who accepted, a license to make use of the Licensed Software, including the Games, under the terms and conditions set forth in the Agreement;
- (B) **WHEREAS** the Parties subsequently amended the Agreement with the First Addendum entered into by the Parties on 1 December 2022;
- (C) **WHEREAS** following the Date of Agreement, the Company has entered into further agreements with Games Providers in terms of which the Company acquired the right to, inter alia, sub-license the New Games to the Licensee;

- (D) **WHEREAS** following the Date of Agreement, the Company and the Licensee have entered into negotiations to amend certain fees as defined in the Agreement;
- (E) **WHEREAS** the Licensee has requested the Company, who accepts, that the New Games shall be added to the Licensed Software and to amend certain fees and the Parties have therefore agreed to enter into this Addendum to add the New Games to the Licensed Software and to incorporate the amended fees into the Agreement.

NOW THEREFORE, the Parties have agreed:

1. Paragraph (ii) of Section B of Appendix III of the Agreement shall be amended to read and substituted in its entirety by the following:

The Licensed Games Fee to be paid monthly by the Licensee to the Company varies depending on the type of Game and on the Games Provider.

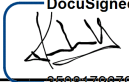
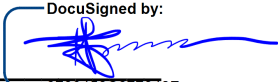
Example: Scale is 0-100.000 EUR 10%, over 100.000 EUR 9%. The monthly GGR is 250.000 EUR. The 10% shall apply to the first 100.000 EUR and the 9% fee shall apply to the second 150.000 EUR. Therefore, the monthly fee in this case would be 23.500 EUR.

2. The remaining provisions of Section B of Appendix III of the Agreement shall remain unamended.
3. The amendments provided in this Addendum shall come into force from the Effective Date, subject to the same terms and conditions of the Agreement.
4. The Parties hereby declare that apart from the amendments to the Agreement as provided in this Addendum, the Agreement, as possibly amended from time to time, shall remain in full force and shall have full effect with regard to all other clauses previously agreed to in the Agreement.
