We have received your email formally requesting that the CGA revoke the license of MSD Tech B.V. with the application number OGL/2024/1416/0660.

Further to your request, we would like to provide the information below.

As outlined in Article 2.4, paragraph 2, sub e, of the National Ordinance on Games of Chance (Landsverordening op de Kansspelen, "LOK"), the revocation of a license can be requested by the licensee. Based on Article 2.4, paragraph 3 of the LOK, the Curaçao Gaming Authority may impose specific conditions to ensure the protection of players and the integrity of the gaming sector.

In order to process your request, please revise your letter to include the information outlined below:

1. A letter signed by the Managing Director stating the request and the reason for the request.
