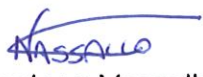

Collectively, the "Partnerships" and each individually a "Partnership".

Limited partners of the Partnerships shall be referred to as the "Partners" and each individually as a "Partner".

Anti-Money Laundering

As an FCA Authorised Person, Bridgepoint Advisers Limited has taken steps to confirm the identity of the Partners as required by the Money Laundering, Terrorist Financing and

Transfer of Funds (Information on the Payer) Regulations 2017 (as amended), the FCA's rules and the provisions of the Joint Money Laundering Steering Group Guidance (the "Rules"). Enhanced due diligence has been carried out by Bridgepoint Advisers Limited wherever appropriate pursuant to the Rules.

Copies of identification documents relating to the Partners will be made immediately available to the recipient of this letter where an explicit written request from law enforcement agencies or regulatory bodies is received by the recipient provided there are no relevant restrictions to the contrary.

Bridgepoint Advisers Limited has established and maintains an Anti-Money Laundering (AML) Policy and Programme that, at a minimum, includes written policies, procedures and internal controls (the "Policies") designed to (i) prevent, detect and report money laundering (ii) adequately train staff and (iii) follow international recommendations with regard to sanctions against persons and entities. The Policies also require Bridgepoint to perform appropriate due diligence to identify each Partner.

As is ordinary course for private equity structures, the source of funds for the Partnerships is a combination of capital contributions and loan commitments from the Partners.

We have performed appropriate due diligence and are not aware of any activities on the part of those Partners which lead us to suspect that the Partners have been involved in money laundering or other criminal conduct.

Ownership of Investments

The Partnerships ultimately hold their shares in investments in the name of a nominee company, BE VI Nominees Limited. No natural person has or controls 25% or more of the economic interests or voting rights in, or otherwise exercises significant influence or control of, the Partnerships as a whole.

BE VI Nominees Limited and Bridgepoint Advisers Limited's ultimate parent company is Bridgepoint Group plc, registered in England and Wales with company number 11443992 and listed on the London Stock Exchange (LSE:BPT).
