- b. They have entered into this Agreement voluntarily and without any form of coercion or undue influence.

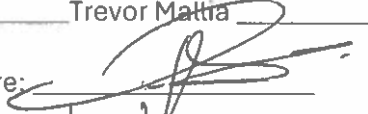

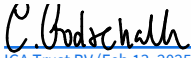
