

SHAREHOLDER LOAN AGREEMENT

This Shareholder Loan Agreement ("Agreement") is made on 1 February 2026

1. Parties

Lender (Shareholder / UBO)

(the "Borrower")

The Lender and Borrower shall collectively be referred to as the "Parties."

2. Purpose of Loan

The Lender agrees to provide funding to the Borrower in order to support the operational expenses, licensing costs, and general working capital of the company.

The Parties acknowledge that this loan forms part of the source of funding for the Borrower in relation to its regulatory application.

3. Loan Amount

The Lender agrees to lend the Borrower the amount of:

USD 115,000

(the "Loan").

4. Funding Timeline

The Loan shall be transferred on or before 30/4/2026, or on another mutually agreed date.

The Parties acknowledge that at the time of signing this Agreement, the loan funds may not yet have been transferred.

5. Interest

The Loan shall bear interest at a rate of 3% per annum on the outstanding principal amount.

Interest shall accrue from the date the Loan is funded and shall be calculated on the basis of a 365-day year.

The accrued interest shall be payable upon repayment of the Loan unless otherwise agreed in writing between the Parties.

6. Repayment Terms

The Borrower agrees to repay the Loan under the following conditions:

- Repayment may be made at any time at the discretion of the Borrower.
- The Loan may also be converted into shareholder equity upon mutual agreement between the Parties.
- No fixed repayment schedule is required unless otherwise agreed in writing.

7. Source of Funds Declaration

The Lender confirms that:

- The funds used for this Loan are legally obtained personal funds.
- The funds originate from personal savings / business income / investment proceeds.
- The funds are not derived from any illegal or unlawful activities.

8. Unsecured Loan

The Parties acknowledge that the Loan is unsecured and no collateral is required.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Taiwan (Republic of China)

10. Default

If the Borrower fails to repay the Loan in accordance with the terms of this Agreement, the Parties shall negotiate in good faith to resolve the matter.

Nothing in this Agreement shall prevent the Parties from agreeing to extend, restructure, or convert the Loan into equity.

11. Entire Agreement

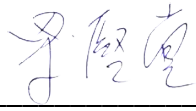
This Agreement constitutes the entire agreement between the Parties relating to the Loan and supersedes all prior discussions or agreements.

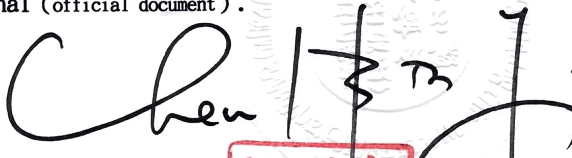
