

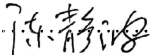

Employment Agreement

This **Employment Agreement** (hereinafter referred to as the "Agreement") is made and entered into on **January 10, 2023**, by and between **Pistis Trade N.V.**, a company incorporated under the laws of Curaçao, with its registered address at **Zuikertuintjeweg Z/N (Zuikertuin Tower), Curaçao**, Registration number: **162576(0)** (hereinafter referred to as the "Company"), and **Chen Jingbo** (hereinafter referred to as the "Employee").

雇佣协议

本**雇佣协议**（以下简称“协议”）于**2023年1月10日**由**Pistis Trade N.V.**（根据库拉索法律注册成立，注册地址为**Zuikertuintjeweg Z/N (Zuikertuin Tower), Curacao**，注册号：**162576(0)**，以下简称“公司”）与**Chen Jingbo**（以下简称“员工”）共同签署。

1. Position and Duties

The Company hereby employs the Employee as **Managing Director**, and the Employee agrees to perform the duties as assigned by the Company with due care, skill, and diligence.

1. 职位及职责

公司同意聘用员工为**总经理（Managing Director）**，员工同意履行公司指派的职责，并以专业、勤勉和尽责的态度完成工作。

2. Term of Employment

This Agreement shall commence on **January 10, 2023**, and shall continue for a term of **5 years**, unless earlier terminated by either party in accordance with the terms set forth in this Agreement.

2. 雇佣期限

3. Compensation

The Company agrees to compensate the Employee as follows:

- **Monthly Salary:** The Employee shall receive a monthly salary of **\$5,000 USDT** (Five Thousand USDT), payable at the end of each calendar month.
- **Bonus:** In addition to the monthly salary, the Employee shall be entitled to an annual bonus equivalent to **2 months' salary**, amounting to **\$10,000 USDT** (Ten Thousand USDT), payable at the end of the fiscal year, subject to the Employee's performance and the Company's financial position.

3. 薪酬

4. Payment Method

The Company shall pay the Employee's salary and bonus in USDT (Tether) to the Employee's designated cryptocurrency wallet. Payments shall be made at the end of each month or as otherwise agreed upon between the parties.

5. Governing Law

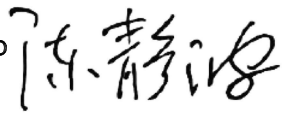
This Agreement shall be governed by and construed in accordance with the laws of Curaçao.

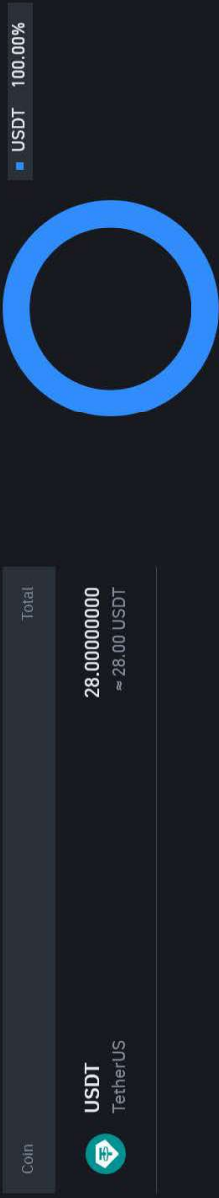
