Terms and Conditions

1. Loan Provision:

The UBO, Denizhan Kocdemir, hereby agrees to provide an interest-free loan of EUR 100,000 (the "Loan") to Monotech Solutions B.V. (the "Company").

2. Loan Nature:

- a. The Loan shall be interest-free.
- b. The Loan shall be governed by the terms mutually agreed upon and set forth in this Agreement.

3. Repayment Terms:

- a. The Loan shall be repaid in full by the Company on or before December 15, 2025 (the "Repayment Date").
- b. Repayment shall be made in a single installment of EUR 100,000, or in equal monthly/quarterly installments of EUR 10,000 beginning on December 15, 2025
- c. Repayment may be made via bank transfer or other agreed methods, details of which shall be provided by the UBO.
- d. Early repayment of the Loan, either in full or in part, shall be permitted without penalty.

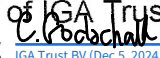
