

Privacy Policy

1. PRIVACY

<https://www.apuesterapido.com/> is committed to protecting your personal information. This Privacy Policy informs you what data we collect when you use our services, why we collect it, and how we use it.

Please note that this Privacy Policy is an agreement between you and <https://www.apuesterapido.com/> (“we,” “us,” or “our,” as applicable). This Policy forms an integral part of the Terms and Conditions of <https://www.apuesterapido.com/>.

The website <https://www.apuesterapido.com/> (“Casino,” “Website,” “Company,” “we”) is owned and operated by Twins Games N.V., a company registered under the laws of Curaçao, registration number 165516, Address: Zuikertuintjeweg Z/N (Zuikertuin Tower), Willemstad, Curaçao.

We may modify this Privacy Policy periodically, notifying you of changes by publishing the updated terms on our platforms. We recommend reviewing this Policy regularly.

2. INFORMATION COLLECTED

We consider as personal information (“Personal Information”) any data that can identify you, including but not limited to: first and last name, date of birth, address, email, phone number, and others. When using our site, creating an account, or accessing our services, we may request this information. We also collect: contact information, payment methods, transaction history, usage preferences, and comments.

Our servers (located in Germany and other regions) store unique records of your activity, including: IP address, date and time of access, pages visited, language used, error reports, and browser type. This information is essential to provide our services. We do not collect personal information without your knowledge.

3. METHODS OF DATA COLLECTION AND PROCESSING

We automatically collect certain data as mentioned above, in addition to receiving information that you provide during the use of the services. We may receive information from external providers, online service providers, and legally acquired customer lists. We may also employ third parties for technical support, payment processing, and account administration.

We access the information provided to these providers and process it according to this Policy. We do not share this information with third parties except under the terms stipulated herein. We take steps to protect your privacy through proper agreements with our providers.

4. USE OF INFORMATION

We use your personal information to provide our services, customer support, security and identity verifications, payment processing, participation in promotions, and general operational purposes.

We may also share your information with carefully selected partners. We may use your data to:

1. Offer you promotions and information about our products and services.
2. Offer you products and services from third-party partners.

Participation in surveys and contests is optional. The requested information may include name, address, phone number, age, etc. By accepting prizes, you consent to the promotional use of your name without additional compensation, unless prohibited by law.

Unless you have opted out of communications, we may send you news and promotions (casino games, poker, betting, etc.) by email or phone.

5. EXCEPTIONAL DISCLOSURES

We may disclose your Personal Information if:

1. It is required by law or similar legal processes.
2. It is necessary to protect our rights or property.
3. It is necessary to protect the safety of our users or the public.
4. In cases of fraud, use of stolen cards, game manipulation, or money laundering, we will share your information with other platforms, banks, card issuers, and competent authorities.
5. For addiction prevention, some data may be anonymized and shared with specialized institutions.

6. ACCESS

You may opt out of receiving promotional communications through your account or by requesting it by email to support. You may also:

1. Confirm the accuracy of your data,
2. Update your personal information,
3. File a complaint about the use of your data.

We may update or restrict the use of your data as necessary. This Policy does not prevent us from retaining information legally required.

7. COOKIES

When using our services, we may store cookies on your device. Cookies are text files that remember your preferences. We also use similar “flash cookies.”

Cookies help to:

- Monitor traffic
- Improve services
- Personalize the user experience

Types of cookies:

- Necessary: enable navigation and basic functions.
- During registration: store session data and preferences.
- Persistent: remain on the device according to your configuration.
- Analytical: analyze user behavior.

You can accept or reject cookies from your browser settings. For flash cookies, use the Flash Player Settings Manager to prohibit their storage.

8. CONSENT FOR THE USE OF PAYMENT SYSTEMS

To play with real money, it is required to send/receive funds. We use third-party electronic payment systems. You agree to the use and international transfer of your personal data to process these transactions.

9. CONSENT FOR SECURITY ANALYSIS

We may perform security audits to validate your information, monitor transactions, and detect violations of our Terms or the law. You authorize us to verify your information through third parties and agree to provide documents if requested.

10. SECURITY

We protect your information through secure systems, including encrypted and password-protected databases, hosted behind firewalls. We use 128-bit SSL and require our partners to implement equivalent security measures.

11. PROTECTION OF MINORS

Our services are not directed to persons under 18 years of age (or the legal age in your jurisdiction). We reject registrations from minors and delete any information they have provided.

12. INTERNATIONAL TRANSFERS

Your information may be stored or processed outside your country. By using our services, you accept such international transfer of data. We ensure that our partners respect our privacy standards.

13. THIRD-PARTY PRACTICES

We are not responsible for how third-party websites with which we have links or associations (such as affiliate programs) handle your data. Collection by third parties is governed by their own privacy policies.

14. DISCLAIMER

Our services operate “AS IS” and “AS AVAILABLE.” We do not guarantee the absence of errors nor assume responsibility for events beyond our control. We will not be liable for indirect damages arising from the use or disclosure of data.

15. CONSENT TO THE PRIVACY POLICY
