Dear Mr. Manasejev,

This letter confirms your appointment as the AML/Compliance Officer of Bettor IO N.V., represented by the company representative Jaroslav Rožkov, effective 1 July 2025. This appointment is made in accordance with the Anti-Money Laundering and Counter-Terrorist Financing regulations applicable to licensed gaming operators in Curacao and is intended to meet the requirements of the Curacao Gaming Control Board (GCB).

1. Role and Scope of Duties

- Implementation and maintenance of AML/CTF prevention measures in accordance with Curacao regulatory requirements.
- Implementation of customer due diligence (CDD) measures.
- Legal compliance management across all company operations to ensure adherence to applicable laws and regulations.
- Continuous monitoring of operations, investigating internal Suspicious Transaction Reports (STRs), Suspicious Activity Reports (SARs), and complaints, as well as liaising with supervising institutions during investigations.
- Maintaining and delivering compliance management information to the Board of Directors and relevant authorities upon request.

- Conducting legal evaluations, assessments, and consultations on various legal matters impacting compliance.
- Preparing, reviewing, and updating contracts and other legal documents to ensure compliance with applicable laws and regulations.
- Representing the company before public institutions and regulatory authorities when required.

2. Authority

In carrying out your role, you will have the authority to access all relevant company records, request information from staff and management, and liaise directly with the Curacao Gaming Control Board and other competent authorities.

3. Reporting Line

You will report directly to the Board of Directors of Bettor IO N.V. and provide regular updates on AML/CTF compliance status, risks, and mitigation measures.

4. Term

This appointment will commence on 1 July 2025 and will remain in effect until terminated by either party in accordance with applicable laws and regulations.

5. Remuneration

You will be compensated at a rate of 2500 EUR per month, payable in accordance with the company's payroll schedule. Applicable taxes or statutory deductions will be withheld in accordance with the law.

6. Confidentiality

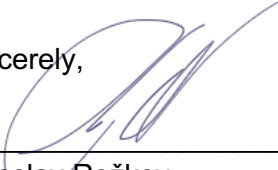
You agree to maintain the confidentiality of all proprietary, personal, and sensitive information relating to Bettor IO N.V. and its clients, both during and after your engagement.
