1. EXECUTIVE SUMMARY

JetTon B.V. (hereinafter “JetTon”, “Company”, “Online Casino”) is an online casino business operating under the laws of Curaçao.

The Company will operate as a virtual gambling platform having registration and login procedure will be accessible through the popular messaging app Telegram.

JetTon offers a variety of casino games and betting options to users, allowing them to play casino games and potentially win real money. It will be focused on offering its products and services to its customers all around the world while ensuring it conforms to the international laws of online gaming platforms. JetTon will be a network based online casino business which will be owned and managed by JetTon B.V.

The following factors make JetTon an unique online-casino:

- 1) **Convenience:** The customers can login on the website using its profile in the Telegram app. No need to download additional apps or visit external websites.
- 2) **Decentralization:** JetTon will operate on blockchain technology, providing a decentralized and transparent platform. This can foster trust among players as they can verify the fairness of games.
- 3) **Fast Transactions:** Cryptocurrencies enable near-instantaneous deposits and withdrawals, making it convenient for players. Traditional online casinos may have longer processing times for payments.
- 4) **Lower Transaction Fees:** Transaction fees for cryptocurrency payments are often lower compared to traditional banking methods, reducing costs for players
- 5) **Global Accessibility:** Crypto casinos are accessible worldwide, allowing players from various regions to enjoy JetTon services.
- 6) **Variety:** The customers can choose from a diverse selection of casino games to suit preferences and betting style.
- 7) **Bonuses and Promotions:** Regular promotions, bonuses, and rewards to boost gaming experience. In addition, some players view crypto gambling as an investment opportunity, as they can potentially benefit from cryptocurrency price fluctuations.
- 8) **Security:** Privacy and security are top priorities of the Company. The Company uses encryption and secure payment methods to ensure that transactions are safe.
- 9) **Customer Support:** Support team is available to assist customers with any questions or concerns.

JetTon aims to comply with the laws of Curacao in the course of running our online casino business. We are in the Global Casinos and Online Gambling industry for the sole purpose of making profits.

1.1. Products and services

The Company will primarily generate revenues from the taking of bets on behalf of players that become enrolled members of the casino. The games hosted on the Company's services will include blackjack, poker, roulette, and several online slot machine style games, etc. The business is aimed to generate revenues from various sources, similar to traditional online casinos. Here are some key revenue streams:

- 1) **Betting and Wagering:** The primary source of revenue for a casino is the bets and wagers made by players on casino games. The house typically has an edge or advantage in most games, ensuring that over time, it generates profits from player losses.
- 2) **Deposit and Withdrawal Fees:** JetTon may charge fees for depositing and withdrawing funds from player accounts. While these fees are usually small, they contribute to revenue.
- 3) **Subscription Services:** JetTon might offer subscription-based services or premium channels with access to exclusive games or content for a recurring fee.
- 4) **Data and Analytics:** JetTon can monetize player data by selling aggregated, anonymized information to marketers or researchers.

1.2. Mission Statement

1.4. Source of Funds

- A. Initial funding of Jetton B.V. (Curaçao) will be made by the sole shareholder of JetTon B.V. - Mr Kayumov. His net annual income from salary is around USD 82 000 which shall be enough to cover incorporation expenses and license fees, etc.
- B. The Company has concluded Convertible Loan Agreements with Mr. Stanislav Ochkur and Mr. Aleksandr Pankratov (the "Investors") where Investors provide the Company with funding for a total amount of USD 400,000.
Those funds will be used to develop JetTon's business, including: marketing, advertisement, website and further expansion of the Company.
- C. JetTon platform and service development is made by Jetton Ltd (Seychelles), where a development team was engaged on the basis on Option Agreements. Also, there were several investors engaged on a basis of soft-commitments to be ready to cover unexpected pre-trading expenses.

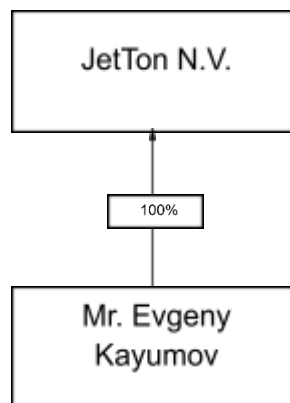
We expect that the business will aggressively expand during the first three years of operation. We intend to implement marketing campaigns that will effectively target individuals within the Company's demographic.

3. PRODUCTS AND SERVICES

3.1. Online Casino Operations

As stated in the executive summary, the primary revenue center for the business will come through the ongoing placing of bets by customers with the Company among online games such as virtual slot machines, etc. With these games RTP will be used. RTP stands for "Return to Player," and it's a crucial concept in the world of gambling and casino games. RTP represents the percentage of all wagered money that a casino game or slot machine is expected to pay back to players over time.

Here's how RTP works for players:

- 1) **Percentage Value:** RTP is expressed as a percentage, typically ranging from 90% to 99% or more. For example, if a slot machine has an RTP of 95%, it means that, over the long term, it's expected to return 95% of all bets to players as winnings.

- 2) **Long-Term Perspective:** RTP is a statistical measurement calculated over a long period of gameplay. It doesn't guarantee that every player will win back precisely 95% of their bets, but it indicates the overall return for all players.
- 3) **Higher RTP, Better Odds:** Players generally prefer games with higher RTP values because they offer better odds of winning over time. A game with a 95% RTP is typically more favorable for players than a game with an 85% RTP.
- 4) **Variance and Risk:** RTP doesn't account for the short-term variability in results. Players can still experience streaks of losses or wins, even in a game with a high RTP.
- 5) **Strategy and Skill:** While RTP reflects the inherent odds of a game, some games involve skill or strategy that can influence outcomes. Games like poker and blackjack, for example, have elements of skill and decision-making that can impact player results.

JetTon will use basic settings of games. The basic settings of online casino games can vary depending on the specific game and the software provider.

3.2. Advertising Revenues

The revenues will come from the sale of advertising space to businesses. At the onset of operations, the business will develop a relationship with Google AdSense so that the business can immediately generate revenue. Each time a visiting user clicks on one of the advertisements for the business, the Company receives a payment from Google. These ads will be tastefully placed throughout the Online Casino platform. The Company also intends to develop its own internal advertising programs that will feature static advertisements within the website. These advertisements will be sold directly to advertisers rather than through a third-party system, like Google AdSense. In the future, the Online Casino will also seek to develop product affiliation and corporate sponsorship relationships which would further the Company's visibility and revenue streams.

4. STRATEGIC AND MARKET ANALYSIS

4.1. Economic Outlook

This section of the analysis will detail the economic climate, the online advertising and e-commerce industry, the customer profile, and the competition that the business will face as it progresses through its business operations. Online gambling or betting is similar to the rules of playing in physical casinos. The only difference is that it is played in a virtual environment where the players are not in proximity to one another. The first venue that allowed online gambling was in 1994 and by the start of the century, more than 8 million people had already participated in some form of online gambling activities. With the growth in technology, the global market players

have managed to maintain a stronghold amongst the consumer group by constantly reinventing products and services and navigating through the various roadblocks laid in front of them.

Key Insights:

- as per the analysis shared by our research analyst, the global online gambling & betting market is estimated to grow annually at a CAGR of around 11.8% over the forecast period (2022-2030);
- in terms of revenue, the global online gambling & betting market size was valued at around USD 58 billion in 2021 and is projected to reach USD 182.21 billion, by 2030;
- the market is projected to grow at a significant rate due to the growing sales of smart devices causing an increase in accessibility;
- based on gaming device segmentation, the desktop was predicted to show maximum market share in the year 2021;
- based on gaming type segmentation, sports betting was the leading type in 2021.

4.2. Customer Profile

The Online Casinos average client will be a young middle to upper middle-class male or female that has a broadband internet connection. Common traits among end users will include:

- 1) annual household income exceeding \$50,000;
- 2) between the ages of 18 (in some jurisdictions is 21) and 40;
- 3) has high speed internet access;
- 4) is familiar with the concept and operations of online casinos;
- 5) will spend \$100 to \$200 per usage of the Online Casino.

4.3. Target Markets

JetTon aims to strategically target specific markets to optimize growth and profitability. The choice of target markets is based on careful analysis, considering factors such as market size, growth potential, regulatory environment, and player preferences. Our primary target markets include:

- 1) **CIS Region:** The Commonwealth of Independent States (CIS) is a diverse region with varying regulations on online gambling. We will carefully select CIS countries with favorable regulatory environments and a demonstrated interest in online gaming. This approach allows us to tap into the diverse CIS market while managing regulatory risks effectively. Revenue in the Online Gambling market is projected to reach US\$67.03m in 2023. Revenue is expected to show an annual growth rate (CAGR 2023-2027) of 6.91%, resulting in a projected market volume of US\$87.56m by 2027.
- 2) **Brazil:** Brazil has a large and growing population with a rising interest in online gambling. Recent regulatory changes have paved the way for legalized online casinos. The combination of a vast potential player base and evolving regulatory conditions makes

Brazil a key market for expansion. Revenue in the Online Gambling market is projected to reach US\$1.58bn in 2023.

5.2. Marketing Strategies

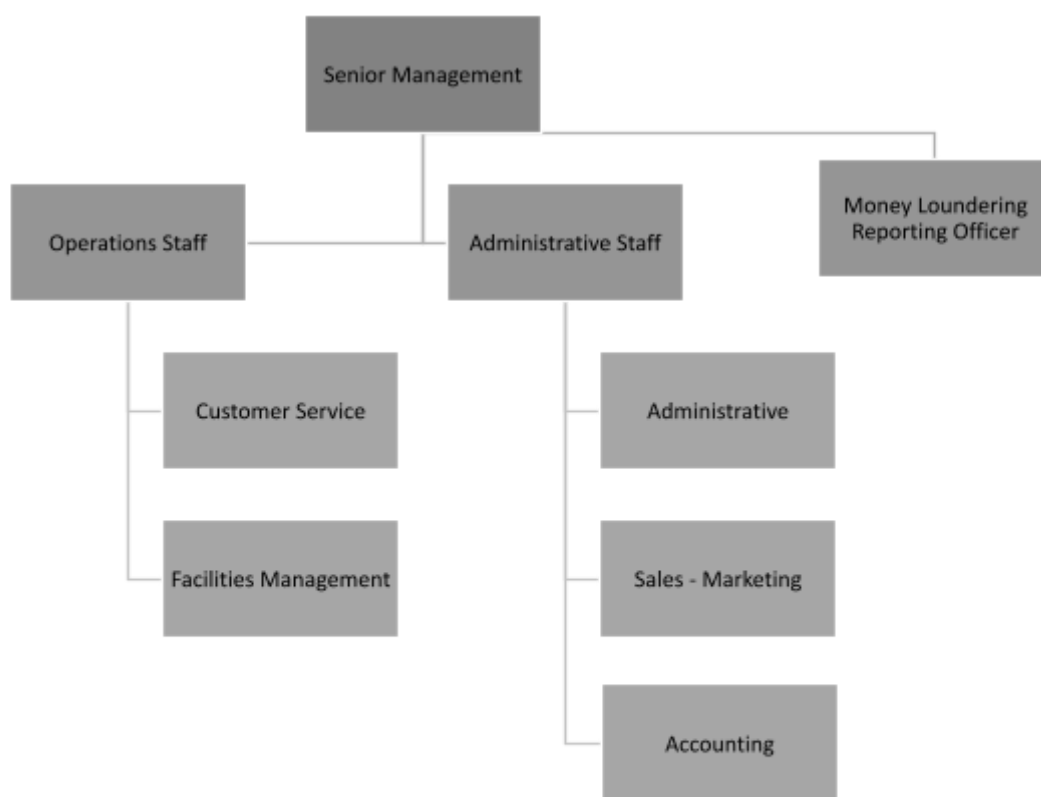

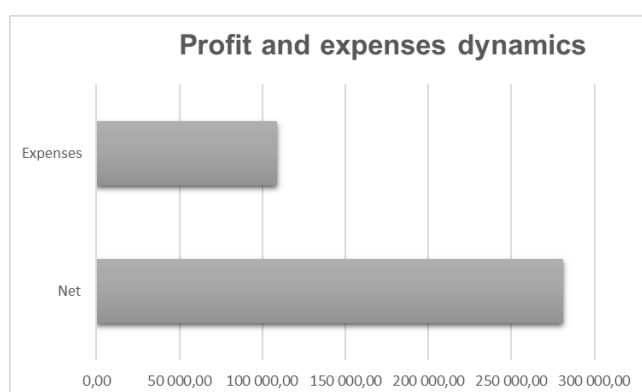

8.8. Geographic Restrictions

JetTon prohibits the registration of a game account and / or making any monetary means to Players who are located in or reside in Afghanistan, Australia, Belarus, Belgium, Côte d'Ivoire, Cuba, Curaçao, Czech Republic, Democratic Republic of the Congo, Denmark, France, Germany, Greece, Iran, Iraq, Italy, Liberia, Libya, Lithuania, Netherlands, North Korea, Ontario, Portugal, Serbia, Slovakia, South Sudan, Spain, Sudan, Syria, Switzerland, United Kingdom, United States, Venezuela, Zimbabwe (the "Prohibited Jurisdictions") are not permitted make use of the Service. For the avoidance of doubt, the foregoing restrictions on engaging in real-money play from Prohibited Jurisdictions applies equally to residents and citizens of other nations while located in a Prohibited Jurisdiction.

Players are not allowed to deposit money if the source of their origin is from Prohibited Jurisdictions.
