GENERAL

Company's Information and Principal Activities

Marcentra Corporation N.V., former GCC Solutions N.V., is a limited liability company that was incorporated in Curaçao on September 27, 2019. The name of the Company has been amended on June 19, 2025.

The Company is registered with the Chamber of Commerce and Industry of Curaçao under number 151335.

The Company's activities are to organize, market, promote, manage, support and operate all types of remote gaming activities.
