1. Loan Provision:

2. The UBO, **Denys Koblia**, hereby agrees to provide an interest-free loan of EUR **100,000.00** (the "Loan") to **Rocket Play B.V.** (the "Company").

- b. They have entered into this Agreement voluntarily and without any form of coercion or undue influence.

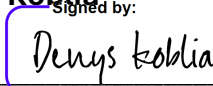

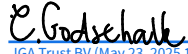
