

LOAN AGREEMENT

This shareholder loan agreement ("Agreement") documents a loan arrangement between APOLLO SYNC B.V. ("Company") and Look Jun Chern ("Shareholder"), the sole shareholder of APOLLO SYNC B.V.,

by and between:

Lender: Look Jun Chern, holder of passport number A61966359, an individual (hereinafter referred to as the "Lender"),
and

Borrower: APOLLO SYNC B.V., a company incorporated in Curaçao with its registered address at Chuchubiweg 17 and registration number 168482 (0) (hereinafter referred to as the "Borrower").

The Lender agrees to loan Borrower funds, as required, to operate APOLLO SYNC B.V. business. This Agreement is made and effective on October 1, 2024;

1. Loan Amount

The Lender agrees to lend the Borrower the amount of EUR 200,000 ("Loan") for the purpose of operational funding during the company's formation and early-stage setup.

2. Disbursement

The Loan shall be disbursed by the Lender directly from the Lender's personal bank account to cover the Borrower's operational costs, or transferred to third parties on behalf of the Borrower. Such disbursements may be made periodically as required by the Borrower.

3. Interest

The Loan shall be interest-free, unless otherwise agreed in writing by both parties.

4. Repayment

The Borrower shall repay the Loan in full on or before October 1, 2026, or on demand by the Lender with 30 days' written notice. The Borrower may prepay all or any part of the Loan at any time without penalty.
