

SPECIAL POWER OF ATTORNEY

This Power of Attorney is made on the 1st day of November 2025.

- The Attorney is prohibited from entering into agreements with third parties, including agreements related to software, hardware, and any other agreements outside of banking and operating activities specified in points 1 and 2 above and outside agreements specified in point 4 below.

4. Special Authorization

- The Attorney is allowed to sign loan agreements on behalf of the Company for the sole purpose of the funding of the business capital required.

AND IT IS HEREBY AGREED THAT:

- This Power of Attorney shall remain in force until the 1st day of November 2026, inclusive, or until earlier notice of the Company having revoked the same shall have been received by the said Attorney or by the Company's Managing Director to whom all enquiries regarding its validity should be addressed.
