General information

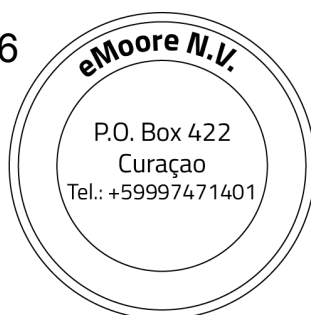
We are pleased to present you with the Annual Report for the period January 1, 2024 through December 31, 2024.

Notes to the financial statements

General notes

The most important activities of the entity

BettingSpoon B.V. is a limited liability company that was incorporated in Curaçao on April 4, 2022.

The company is registered with the Chamber of Commerce and Industry of Curaçao under number 160448.

The company's principal activities are to organize, market, promote, manage, support and operate all types of remote gaming activities, comprising all types of games, betting and other interactive games.

General accounting principles

The accounting standards used to prepare the financial statements

The financial statements have been prepared in accordance with Book 2 of the Curaçao Civil Code using the Guidelines for annual reporting of the Dutch Accounting Standard Board.

Comparison with previous year

The principles of valuation and determination of result remained unchanged compared to the previous year.

Accounting principles

Current assets

Current assets are initially valued at the fair value of the consideration to be received, including transaction costs if material. Trade receivables are subsequently valued at the amortised cost price. Provisions for bad debts are deducted from the carrying amount of the receivable.

Accounting principles for determining the result

General

The result is determined as the difference between income generated by the supply of services, and the costs and other charges for the year. Income from transactions is recognized in the year in which it has been realized; losses are taken as soon as they are foreseeable.

Exchange rate differences

Exchange rate differences arising upon the settlement of monetary items are recognized in the Profit and Loss Account in the period that they arise. Exchange rate differences on long-term loans relating to the financing of foreign participations are recognized in the Profit and Loss Account in the period they arise.
