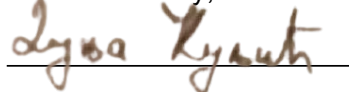

Osnovna zarada, deo zarade za radni učinak i uvećana zarada

The following provisions of the Contract of Employment concluded on **31.12.2020.** are hereby changed:

Article 2 of the Contract of Employment is changed

Basic salary, salary earned based on work performance, and increased salary

The Employee shall receive the following basic annual salary in twelve equal monthly instalments.

Basic annual salary (din) x 12 **857,438.00**
Total annual salary = **10,289,256.00**

The gross variable part (AIB) is **10.00 %** of the employee's total basic annual salary.

Payment of variable portion of the salary for the previous year shall be made in March of the following year and shall depend on the output in accordance with the applicable AIB - Ardagh Incentive Bonus Plan on the bonus calculation day. Variable portion of the total annual salary (AIB) shall be paid as a one-off amount proportionate to the time the Employee spent working with the Employer in the previous year.

Increased salary and reimbursement of expenses shall be paid in accordance with the statutory regulations in force and the company's Work Regulations.

The salary levels shall be reviewed at the beginning of each year.

Salaries shall be paid to the employee's bank account at the latest by the end of the current month for the work done during the previous month.

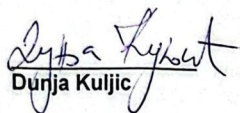

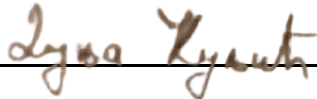
