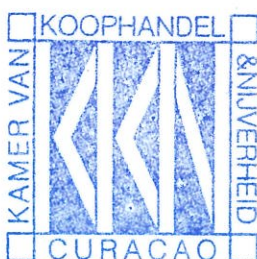

1. To represent and protect the interests of third parties, in the widest sense of the word and particularly:
 - a. to manage, administer and/or manage the financial affairs of assets of any kind, to act as an administrator, trustee or executor, to act as an administrator of unclaimed estates, to act as an agent, to give advice in matters of investment of funds, to conduct the management and keep the accounts of other legal entities and partnerships, irrespective of their stated purpose, and to manage other enterprises, legal entities and partnerships;
 - b. to receive royalties and commissions;
 - c. to acquire, possess, dispose of, encumber, manage, hire, rent, exploit and develop movable and/or immovable property and/or any right or interest in movable and/or immovable property;
 - d. to manage and supervise legal entities, among which, entities operating in and outside an economic zone, entities related to entities in and outside economic zone and entities who have or will have activities on the internet;
 - e. to provide office facilities and domicile for enterprises or corporations;
 - f. to look after the interests of shareholders, debenture holders or other creditors in corporations or groups thereof;
 - g. to act as an intermediary in the incorporation of legal entities and partnerships;
 - h. to act as a liquidator of legal entities and partnerships;
 - i. to undertake the custody of movable property for a consideration in the manner and subject to the terms and conditions to be determined by the Management Board;
 - j. to act as a trust company in the widest sense of the word and to issue in that capacity depositary receipts, registered or to bearer, for the shares of stock and for the debentures entrusted to its custody of legal entities, to collect the dividends and interests thereon to be distributed and to pay over such dividends and interests to the holders of the depositary receipts;
 - k. to take in its name, for the account of third parties, movable and immovable property and to manage such property;
 - l. to participate in and to manage other undertakings, enterprises, companies or corporations;
 - m. to borrow money and to issue promissory notes therefore, as well as to lend money, and to grant security in any form for debts of the company as well for debts of third parties;
 - n. to provide surety bonds and other guarantees, and to transfer in ownership or to mortgage, pledge or otherwise encumber capital assets, all the foregoing for the fulfilment of obligations of debts of the company and of third parties.
2. The operating of an organizational consultancy firm, in particular in the field of compliance consultancy and project management.
3. To perform duties of administration, payroll-, tax- and referral services in the



widest sense of the word.

4. To operate a temporary employment-, secondment- and mediation agency in the widest sense of the word and in connection therewith recruiting, selecting supervising and making available personnel to provide services to companies based in Curaçao in general.

5. The company has the power to perform every act and thing profitable or requisite to the accomplishment of its purpose or connected therewith in the widest sense of the word, including the participation in-, and the incorporation and management of other enterprises and companies.

6. The company is authorized to enter into a corporate agreement in writing as meant in article 2:227 of the Civil Code.
