

DEED OF CAPITAL CONTRIBUTION

This Deed of Capital Contribution (the "Deed") is entered into as of 17th of June 2025 by and between:

1. **NUMERETO B.V.**, a company incorporated under the laws of Curaçao, with its registration number: 163869 and its registered office at: 03, Abraham Mendez Chumaceiro Boulevard, Willemstad, 4750, Curacao ("NUMERETO");
2. **KERIS & KASTEEL LTD**, a company incorporated under the laws of Cyprus, with its registration number: HE 448346 and its registered office at: 11, Filippou, Nicosia, Agios Dometios, Cyprus ("KERIS"),

(collectively – the "COMPANIES"); and
3. **Ms. Olena Chuchman**, citizen of Ukraine, born on 28th of May 1981, with his passport number GJ391556 and registered address at: 111, Sergiia Kolachevskogo, Apt.: 29, Kryvyi Rih, Dnipropetrovska, Ukraine (the "UBO"),

(collectively – the "Parties").

RECITALS:

WHEREAS, the UBO is the sole shareholder of NUMERETO, and the NUMERETO is the sole shareholder of KERIS;

WHEREAS, the UBO is the Ultimate Beneficial Owner of the Companies;

WHEREAS, the UBO and NUMERETO wish to contribute funds to KERIS for the development of its business and to increase KERIS's reserves;

WHEREAS, the UBO and NUMERETO agree to treat this transaction as a capital contribution from the UBO to NUMERETO, creating an equivalent contribution from NUMERETO to KERIS and an obligation on the part of NUMERETO to the UBO;

WHEREAS, NUMERETO and KERIS agree to treat this transaction as a capital contribution from NUMERETO to KERIS;

NOW, THEREFORE, the Parties agree as follows:

1. CONTRIBUTION OF FUNDS

1.1. The UBO shall contribute to KERIS EUR 25,000.00 (the "Contribution") which can be transferred in parts and shall be used for development of the business of KERIS and increase of the reserves of KERIS.

1.2. UBO and NUMERETO agree to treat and reflect this transaction as a capital contribution from the UBO to NUMERETO, establishing an obligation from NUMERETO to the UBO.

1.3. NUMERETO and KERIS further agree to treat and reflect this transaction as part of NUMERETO's capital contribution to KERIS in its capacity as KERIS's sole shareholder.

1.4. KERIS confirms that the Contribution shall be used for the development of its business and to increase its reserves, which can be done in the various forms.

2. ACKNOWLEDGMENT OF TRANSACTION

2.1. All Parties agree that the funds transferred by the UBO to KERIS shall be deemed a capital contribution by NUMERETO in its capacity as the shareholder of KERIS.

2.2. NUMERETO acknowledges that the source of these funds is the UBO and shall document this accordingly in its internal records.

2.3. KERIS acknowledges that the Contribution has been made on behalf of its shareholder, NUMERETO, and shall document this accordingly in its internal records.
