

DEED OF CAPITAL CONTRIBUTION

This Deed of Capital Contribution (the "Deed") is entered into as of 27th of October 2025 by and between:

1. **IRIDIUM GROUP N.V.**, a company incorporated under the laws of Curaçao, with its registration number: 153995 and its registered office at: 17, Chuchubiweg, Willemstad, Curacao ("IRIDIUM");
2. **BABLCHOS LTD**, a company incorporated under the laws of Cyprus, with its registration number: HE 455257 and its registered office at: 5, A.G. Leventi, THE LEVENTIS GALLERY TOWER, Fl.: 13th, Apt.: 1301, Nicosia, 1097, Cyprus ("BABLCHOS"),

(collectively – the "COMPANIES"); and

3. **Mr. Oleh Maletskyi**, citizen of Ukraine, born on 06th of May 1987, with his passport number FT795291 and registered address at: 19, Kashtanova, Apt.: 14, Kryvyi Rih, Dnepropetrovsk, Ukraine (the "UBO"),

(collectively – the "Parties").

RECITALS:

WHEREAS, the UBO is the sole shareholder of IRIDIUM, and the IRIDIUM is the sole shareholder of BABLCHOS;

WHEREAS, the UBO is the Ultimate Beneficial Owner of the Companies;

WHEREAS, the UBO and IRIDIUM wish to contribute funds to BABLCHOS for the development of its business and to increase BABLCHOS's reserves;

WHEREAS, the UBO and IRIDIUM agree to treat this transaction as a capital contribution from the UBO to IRIDIUM, creating an equivalent contribution from IRIDIUM to BABLCHOS and an obligation on the part of IRIDIUM to the UBO;

WHEREAS, IRIDIUM and BABLCHOS agree to treat this transaction as a capital contribution from IRIDIUM to BABLCHOS;

NOW, THEREFORE, the Parties agree as follows:

1. CONTRIBUTION OF FUNDS

1.1. The UBO shall contribute to BABLCHOS EUR 5 000 (the "Contribution") which can be transferred in parts and shall be used for development of the business of BABLCHOS and increase of the reserves of BABLCHOS.

1.2. UBO and IRIDIUM agree to treat and reflect this transaction as a capital contribution from the UBO to IRIDIUM, establishing an obligation from IRIDIUM to the UBO.



1.3. IRIDIUM and BABLCHOS further agree to treat and reflect this transaction as part of IRIDIUM's capital contribution to BABLCHOS in its capacity as BABLCHOS's sole shareholder.

1.4. BABLCHOS confirms that the Contribution shall be used for the development of its business and to increase its reserves, which can be done in the various forms.

2. ACKNOWLEDGMENT OF TRANSACTION

2.1. All Parties agree that the funds transferred by the UBO to BABLCHOS shall be deemed a capital contribution by IRIDIUM in its capacity as the shareholder of BABLCHOS.

2.2. IRIDIUM acknowledges that the source of these funds is the UBO and shall document this accordingly in its internal records.

2.3. BABLCHOS acknowledges that the Contribution has been made on behalf of its shareholder, IRIDIUM, and shall document this accordingly in its internal records.
