This Contract Agreement ("Agreement") is made and entered into on January 09, 2025 by and between:

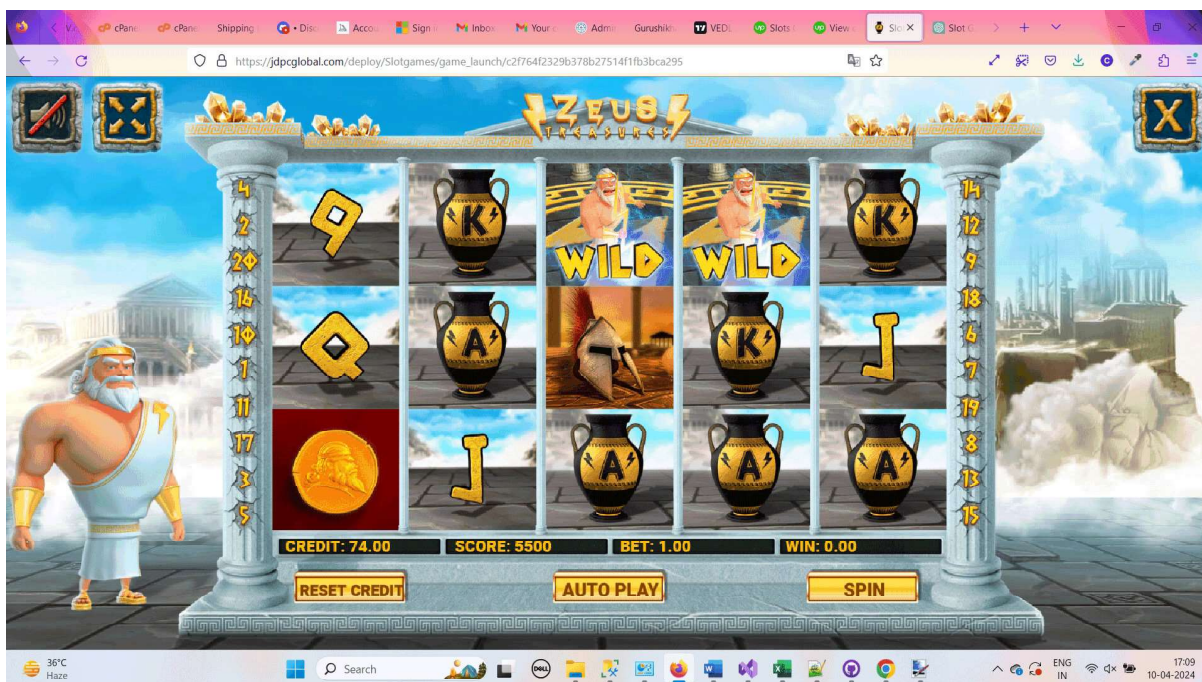
1. Client: TGI ENTERTAINMENT NV ("Client")
2. **Service Provider:** Chaman Saini, representing JDPC Global Pvt Ltd ("Service Provider")

Project Title: Development of a Standalone Slot Game

1. Scope of Work

The Service Provider agrees to develop a standalone slot game ("Game") with the following features:

- **Initial Gameplay Credits:** Players will begin with 1000 points as default credits.
- **Reset Functionality:** Players can reset their credits to the default value of 1000 points at any time.
- **Iframe Integration:** The Game will be integrated into an iframe for easy embedding.
- **Hosting:** The Game code will be hosted on the Client's server.
- **No Login Requirement:** The Game will not require players to log in to play.
- **Game theme :** Game theme will be as shown in below image



2. Timeline

The Service Provider commits to completing the development and any necessary improvements within **15 days** from the start date of this Agreement.

3. Payment Terms

- **Total Agreed Cost:** €700 (Seven Hundred Euros).
 - **Payment Schedule:**
 - 50% (€350) upon signing this Agreement.
 - 25% (€175) upon successful delivery of the Game.
 - 25% (€175) after final testing and approval of the Game.
 - Payments are to be made via bank transfer.

4. Responsibilities

- **Client:**
 - Provide access to the hosting server for deployment.
 - Timely feedback during the development phase.
- **Service Provider:**
 - Deliver the Game with the agreed-upon features.
 - Ensure proper deployment and functioning on the Client's server.



5. Ownership and Rights

- The Client will retain full ownership and rights to the Game upon full payment.
 - The Service Provider retains the right to showcase the Game in their portfolio unless explicitly restricted by the Client in writing.

6. Confidentiality

Both parties agree to keep all project-related information confidential and not disclose it to any third party without prior consent.

7. Revisions and Support

- The Service Provider will accommodate reasonable revisions during the development phase.
 - Post-delivery support for minor fixes will be provided for a period of 30 days.

8. Termination

- Either party may terminate this Agreement with written notice if the other party fails to meet their obligations.
 - In case of termination, the Service Provider will refund any unused portion of the payment based on the work completed.

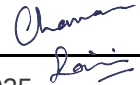
