AGENCY AGREEMENT

This AGREEMENT has been signed between the parties on the 25th day of October 2022.

Of the first part,

Askmebet Holding N.V., a company registered in Curacao with registration number 160834, bearing its registered address at Abraham de Veerstraat 9, Willemstad, Curacao (hereinafter referred to as the **"OPERATOR"**);

AND

Of the second part

Sai Wai Lin Oo, holding a passport number MG161588 issued on 19.07.2022 and residing at No.9/22, Sein Pan Street, Region (9), Pong Hton Ward, Tachileik, Myanmar (hereinafter referred to as the **"AGENT"**)

Hereinafter also referred to individually as "Party" or collectively as "Parties".

1. SUBJECT OF THE AGREEMENT

Pursuant to this agreement, the Operator's objective is to receive referred customers/players from the Agent to the www.askmebet.vip website and have the website promoted among the Agent's player network.

Any further requests not mentioned in this Agreement must be subject to separate agreement and discussion between the parties.

2. CONFIDENTIAL INFORMATION

Any information disclosed by the Parties during the term of this Agreement, including but not limited to personal and corporate information, proprietary plans, and strategies, players' personal data, and their transactions, shall be held in strict confidence. This obligation extends throughout the duration of the Agreement and for a period of one year after its termination or conclusion.

In the event of any interruption of services, including but not limited to the termination of this Agreement, the Parties shall promptly return all exchanged documents and personal information related to the execution of the Agency Agreement to the respective originating Party.

3. RIGHTS AND OBLIGATION

3.1 The AGNET's rights and obligations:

3.1.1 The Agent is obligated to present and promote the Operator's website to its customers, ensuring a high level of visibility;

3.1.2 The Agent is obligated to maintain strict confidentiality concerning any information related to the Operator's personal data or the company's plans and strategies;

- 3.1.3** The Agent is expressly prohibited from engaging in cooperation or referrals of its customers to other operators in direct competition with the Operator during the term of this Agreement;
- 3.1.4** The Agent is mandated to facilitate referred players in the timely execution of deposits and withdrawals on www.askmebet.vip website, the Operator's betting and gaming website, without any undue delays;
- 3.1.5** The Agent is required to provide support to referred players concerning any inquiries they may have regarding ongoing promotions on www.askmebet.vip, the Operator's betting and gaming website.

3.2 The OPERATOR's rights and obligations:

- 3.2.1.** The Operator is obligated to maintain strict confidentiality concerning any information related to the Agent's personal information, the Agent's customer database, and any information discussed between the Parties during the term of this agreement.
- 3.2.2** The Operator is further obligated to keep the Agent informed about ongoing or upcoming promotions, products, and services that can mutually benefit both Parties and be of interest to the Agent's referred clients.
- 3.2.3** the Operator is mandated not to offer more favorable rates to any other agent working for an operator in direct competition with the Agent.
- 3.2.4** The Operator is obligated to implement effective risk management measures to prevent arbitrage players or high-risk players from engaging in activities that could lead to profit losses for both Parties.
- 3.2.5** The Operator is obligated to ensure the website is consistently operational and to provide all necessary games and game providers on the website to maintain its appeal to referred players, nurturing a strong relationship with them, and maximizing the potential for profitable engagement.
- 3.2.6.** The Operator is also obliged to remit the profit generated from referred players to the Operator in full, within a period of 7 business days upon receipt of an invoice from the Operator.

4. LIMITATION OF LIABILITY

- 4.1** The Agent cannot be held liable for referred players who are considered risky or decide to move to a competitor's website due to their dissatisfaction with the Operator's betting website.

5. TERMS OF THE AGREEMENT

- 5.1.** The agreement takes effect immediately upon signing and remains in force until either party terminates the contract, subject to a 2-week notice before termination. Upon notifying the other party, both parties are obligated to fulfill their financial obligations as stipulated in the agreement.

6. TERMINATION OF THE AGREEMENT

6.1. Upon the termination of the agreement, all player databases should be returned to the Agent and not used by the Operator unless the Parties agree to continue the partnership indirectly, and the Operator agrees to pay a commission as per the clause 8% of this agreement.

6.2. If such an agreement is reached, the Agent is obliged not to use the database for referring players to the Operator's direct competitors, thereby preventing financial losses to the Operator.

6.3. Upon the termination of the agreement, both parties shall cease any referrals to each other on their respective agent websites or any other channels used for partnership.

7. COMMERCIAL TERMS

7.1. The Operator is obligated to pay a commission of 7% for referred players' deposits and 5% for withdrawals to the Agent.

7.2 Furthermore, the Operator is also obliged to pay a commission of 40% from the total GGR (Gross Gaming Revenue, calculated as Bet minus Winnings) generated from the referred players within a respective calendar month.

7.3 The commission paid by the Operator to the Agent cannot be carried over to the next month and is not subject to changes.

7.4 In the calendar month when the total GGR generated from the referred players is zero or negative, the Operator is obliged to fully cover it without carrying it over to the next month and deducting it from the Agent's profit

7.5 The Agent's commission may be paid:

1. In cryptocurrency and transferred by the Operator to the Agent's cryptocurrency wallet; both parties should verify and confirm the wallet before each transaction; or
2. By bank transfer to KBZ Bank through bank account number 0065110001958901.

8. Duplicate Originals

This Agreement has been made in two duplicate originals, one for each Party.

9. Amendments

Amendments to this Agreement shall be agreed in writing and signed by both Parties.

10. Governing Law and Court of Jurisdiction

This agreement shall be governed by the laws of the Philippines. Any dispute, controversy or claim deriving from or in conjunction with this Agreement, or a breach, termination or invalidity thereof, shall be exclusively settled by the Courts of Law in the Philippines.

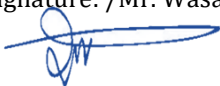

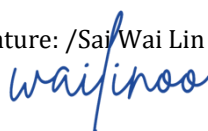
