

Additional agreement
to the SOFTWARE LICENSE AGREEMENT
No. 1-11/20-L dated November 6, 2020

THIS ADDITIONAL AGREEMENT TO THE SOFTWARE LICENSE AGREEMENT (the “**Agreement**”), is made effective in Limassol, Cyprus, on **April 1, 2024** (“**Effective Date**”) by and between

GURUFLOW TEAM LTD, a company (Reg. No. HE 405280), incorporated under the laws of Cyprus, with its place of business at the address: Vasili Michailidi, 9, Limassol, Cyprus, 3026 represented by director D.A.Accounting & Secretarial Limited (hereinafter referred to as the “**Licensor**”), on the one hand, and

Carletta N.V., a company (Reg.No. 142346), incorporated under the laws of Curacao, with its place of business at the address: Dr. Henri Fergusonweg 1, Curaçao represented by authorized signatory Valentina Nedelco (hereinafter referred to as the “**Licensee**”), on the other hand,

hereinafter together referred to as the “**Parties**” and each of them separately to as the “**Party**”, have agreed as follows:

1. To amendment **EXHIBIT A** of the Agreement and add the following modules of the Software:

- **GURU KYC tool** – Solution integration service for customer verification and identification;
 - ✓ Processing, storage and validation of received data.
- **GURU License tools** – A set of sub-services to cover processes related to regulatory requirements;
 - ✓ Service for obtaining of additional information about customers from a third-party customer verification service in registers;
 - ✓ Service for fixing and carrying out returns of GMS;
 - ✓ Service for monitoring and fixing clients who have gaming addiction;
 - ✓ Statistics collection service.
- **GURU Jackpot tool** – Customer bet monitoring service that allows you to evaluate bets in real time and identify customers who have a chance to win;
 - ✓ Online status service, monitors the state of the client's data and provides support services with information for decision-making.

2. To amendment the paragraph «**License and Support Fees**» of the **EXHIBIT A** of the Agreement and state it in the following wording:

«Licensee shall pay the following License Fees on a monthly basis for an initial term of **one (1) year** from the Effective Date of this Agreement (the “Initial Term”):
