

Additional Agreement No.1
to the Software License Agreement No. 1-11/20-L

This Additional Agreement No.1 to the Software License Agreement No. 1-11/20-L (the "***Additional Agreement***") is made effective on December 1, 2021 ("***Effective date***") by and between

GURUFLOW TEAM LTD, a company (Reg. No. HE 405280), incorporated under the laws of Cyprus, with its place of business at address: Vasili Michailidi, 9, Limassol, Cyprus, 3026, represented by Attorney Dmitriy Punin (hereinafter referred to as "***Licensor***"), on the one hand, and

CARLETTA N.V., a company (Reg. No. 142346), incorporated under the laws of Curacao, with its place of business at address: Perseusweg 27A, Curaçao, represented by Attorney Ilia Zudilin (hereinafter referred to as "***Licensee***"), on the other hand, hereinafter together referred to as the "***Parties***" and each of them separately to as the "***Party***", have agreed to make amendments to the Software License Agreement No. 1-11/20-L (hereinafter referred to as "***Agreement***"), as follows:

1. Amendment to Clause 2: **Fees and Payment**

The Parties hereby agree to change the period the Licensee shall pay all invoices and thus make the section *a.Fees* of the Clause 2 of the Agreement in another wording as stated herein below:

"a. Fees. Licensee shall pay to Licensor all license fees ("License Fees"), support and maintenance fees ("Support Fees") and other fees as set forth in the applicable Order Form. Unless otherwise set forth in the in the applicable Order Form, Licensee shall pay all invoices in full within *two hundred seventy (270) days* of the date of the receipt of the invoice."

2. Amendment to Exhibit A (Initial Order Form): **License and Support Fees; Exhibit Term**

The Parties hereby agree to change the period the Licensee shall pay the monthly License Fees and thus make the part four of the Paragraph **License and Support Fees; Exhibit Term** of the Exhibit A to the Agreement in another wording as stated herein below:

"The monthly License Fee for the first month is due on the Effective Date of the Agreement. The monthly License Fees for the balance of the Exhibit Term are payable within *two hundred seventy (270) days* after the receipt of the invoice".

3. These terms will take on place on **December 1, 2021**.

4. This Additional Agreement shall be considered an integral part of the Agreement and shall be applied and interpreted in conjunction with the provisions of the Agreement.

5. Except as amended by this Additional Agreement, the Agreement shall remain in full force and effect according to its terms and shall be read and construed as if the terms of this Additional Agreement were included therein.

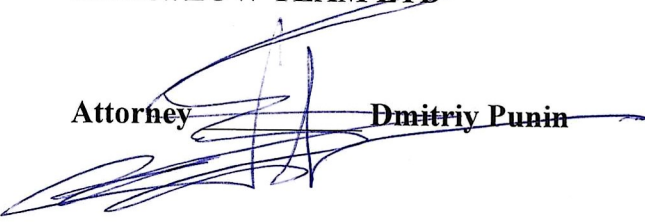
