1. INTRODUCTION

1.1. By accessing or using any part of the <https://www.pin-up.casino/> (hereinafter referred to as “the Website”), including creating an account and participating in its services, you confirm that you have read, understood, and agreed to the Terms and Conditions, Privacy Policy, Game Rules, and Bonus Terms outlined on the Website (collectively referred to as the “**Terms**”). We advise all users to carefully review these Terms before proceeding. These Terms form a legally binding agreement between you, as the player, and the Casino. By registering and placing wagers, you acknowledge full acceptance of the Terms. If you do not agree, you must discontinue use of the Website and its services. Continuing to access the Website indicates your consent to comply with these Terms.

1.2. <https://www.pin-up.casino/> is operated by **Carletta N.V.** (“the Company”, “we”, “us”, “our”) having its office at **Dr. Henri Fergusonweg 1, Willemstad, Curacao**, company registration number **142346**, which is licensed by the Curaçao Gaming Control Board since July 01, 2024, to offer games of chance under license number OGL/2024/580/0570 in accordance with the National Ordinance on Offshore Games of Hazard (Landsverordening buitengaats hazardspelen, P.B. 1993, no. 63) (NOOGH), and its wholly-owned subsidiaries **B.W.I. BLACK-WOOD LIMITED** is a company registered and established under laws of Cyprus, with the company registration number HE 405814 and registered address Panagioti Toumazou, 37, Episkopi, 4620, Limassol, Cyprus and **Carletta Limited** is a company registered and established under laws of Cyprus, with the company registration number HE 360353 and registered address Riga Feraiou, 7-9 Lizantia Court, Office 310, Agioi Omologites, 1087, Nicosia, Cyprus acting as payment agents of the company Carletta N.V.

1.3. Reference to “**you**”, “**your**”, “**customer**”, “**user**” or “**player**” shall mean any person using the Website or any services available thereon and/or any registered customer of the Website.

1.4. Reference to “**Games**” shall mean Casino, Live Casino, Sportsbook, cards, and other games as may from time to time become available on the Website. We reserve the right to add and remove Games from the Website at its own discretion.

1.5. By accepting these Terms and Conditions, you acknowledge that you are fully informed about the rules governing the games provided on the Website. It is your responsibility to understand the expected return rate (theoretical payout percentage) for each game offered.

1.6. Should any of your winnings be subject to taxes under the laws of your country or any relevant regulatory body, you are responsible for declaring your winnings and losses to the appropriate authorities. Additionally, you are solely accountable for settling any taxes or charges arising from your winnings on the Website.

1.7. **Using VPN to bypass provider’s block is strictly prohibited and may lead to account closure and confiscation of winnings.**

2. CHANGES TO TERMS AND CONDITIONS

2.1. The Company reserves the right to implement changes to these Terms and Conditions, including those related to software, service provisions, player requirements, or those necessitated by legal obligations, without prior notice. All such changes will take effect once the updated Terms are published on the Website.

2.2. It is the responsibility of each player to review the current Terms regularly. The Company retains the authority to amend, edit, update, or modify these Terms at its discretion and without prior notification. These modifications may be made for various reasons, including compliance with new laws or regulations, as well as improvements to customer service.

2.3. If you disagree with these changes, you are advised to discontinue use of the website and, if applicable, follow the guidelines outlined in the "**Account Closure**" section of these Terms for account closure. Usage of any part of the website after the implementation of revised Terms will be regarded as your agreement to and acceptance of the updated Terms, including any additions, removals, substitutions, or other adjustments to the Company's contact information, as specified in this section of the Terms.

3. LEGAL REQUIREMENTS

3.1. The Company operates in compliance with the laws and regulations governing online gambling. Players are solely responsible for ensuring that online gambling is legal in their jurisdiction before using the Website. It is essential to verify the applicable laws and gambling regulations in your country prior to participating.

3.2. Players must meet the minimum legal age for gambling in their jurisdiction ("**Eligible Age**"). Individuals under the age of 18, or below the required age, are strictly prohibited from accessing the services. If the Company suspects that a player is underage, we may request age verification documents at any time. Failure to provide the requested proof of age may result in account suspension and denial of services.

3.3. Recognizing that minors may have access to the internet, we encourage parents to prevent children from accessing the Website. To assist in this effort, we recommend using filtering software. For more information, please refer to the following resources:

3.4. By using the Website, you confirm that you are in compliance with all local laws, statutes, and regulations concerning online gambling. The Company does not provide legal advice and cannot guarantee that using the Website will be legally permissible in all jurisdictions. The Company is not responsible for any illegal or unauthorized use of the Website.

3.5. You accept full responsibility for ensuring that your use of the Website adheres to the laws of your country. The decision to access and use the Website is entirely at your own risk, and the Company is not liable for any legal consequences.

3.6. **Restricted Countries** The Company restricts players from certain countries and territories ("**Restricted Countries**") from depositing funds or participating in real-money games. Players from the following regions are prohibited from accessing these services:

- United States of America and its territories
- France and its territories
- Netherlands and its territories, including Bonaire, Sint Eustatius, Saba, Aruba, Curaçao, and Sint Maarten
- Australia and its territories
- United Kingdom of Great Britain and Northern Ireland
- Germany
- Democratic Republic of Korea
- Iran
- Myanmar

3.7. **Bonuses and Promotions** Players residing in Sweden are not eligible for any bonuses, VIP rewards, promotional offers, or comp point exchanges.

3.8. In addition, customers from Armenia are prohibited from using the Sport section on the Website. If the website administration finds out that any sporting bets have been made by residents of Armenia, all these bets may be annulled (settled with odds of 1/1).

3.9. Withdrawal and Refunds If a player violates the Restricted Countries policy, the Company cannot guarantee the successful processing of withdrawals or refunds.

3.10. Age Verification To ensure compliance, the Company reserves the right to request proof of age from players. Access to the Website may be restricted, or accounts suspended, if players fail to meet the age requirement or provide the necessary documentation.

4. RESPONSIBLE GAMING

4.1. Please read our [Responsible Gaming policy](#) before using your account. We take Gaming Addiction very seriously and are committed to preventing it from harming our users.

5. YOUR ACCOUNT

5.1. To access and use the Website, you must create an account, (hereinafter “your Account”). This process requires you to provide your email address, mobile phone number and set a password for login purposes. Additionally, to get full access to all Website functions, during the registration process provide the Company with your personal information, including your name, date of birth, passport information, city and address of residence.

5.2. The first and last names as well as the date of birth you specify when registering must be your true real personal information. The Company may request identification documents, such as a passport or ID card, as well as payment card information, to verify the details provided. This procedure is called Account Verification, and the Client who successfully provided all required documentation can be referred to as the Verified Client. The Client can attach a copy of their identity document in their Personal account, under Profile, Document upload section at any time, including immediately after their registration and before or after a withdrawal request. If you fail to submit the requested documentation, the Company reserves the right to suspend your account until the required information is provided or to terminate your account entirely.

5.3. Account verification is carried out by our financial or security departments during workdays from Monday to Friday, except for cases when user account verification is essential to process an active request for funds withdrawal.

5.4. You confirm that when registering on the Website, you provide real and accurate personal information about yourself, and in case any of this information changes, you are obliged to notify us in a timely manner. If you do not meet these requirements, we reserve the right to restrict your account and further fully close it, voiding all transactions (bonuses, winnings) as well as all bets and their winnings.

5.5. You acknowledge that your account is accessed using a unique username and password that you select.

5.6. Upon account creation, you agree not to share your username and password with any third parties, whether intentionally or unintentionally. If you forget or lose your login credentials, you can reset your password by selecting the "Forgot Password" link on the Website.

5.7. We implement strict measures to protect your personal information from unauthorized use. Your data is only accessible to those directly involved in providing services on the Website. However, we cannot be held liable for the use of this information by third parties such as affiliates or software vendors.

5.8. We may contact you via the phone number provided in your account as part of the Know Your Customer (KYC) procedure. Your account or any actions within it may be suspended until verification is completed. If we are unable to contact you within two (2) weeks after a withdrawal request, your account will be locked due to failure to complete the KYC process.

5.9. We reserve the right to refuse the opening of a player's account at our discretion.

5.10. If you experience any issues or have questions during the registration process, please feel free to reach out to our support team at support@pin-up.support.

5.11. The Website is strictly for personal use and may not be utilized for any commercial gain.

6. ACCOUNT ISSUES

6.1. If you forget your password or think that somebody knows the details of your personal data, moreover if you suspect that another user is taking an unfair advantage through cheating or collusion you must report the suspicion to us.

6.2. We reserve the right to declare any transaction void partially or in full if we, at our own discretion, would deem it obvious that any of the following circumstances have occurred:

- Account holder or people associated with the Account holder may directly or indirectly influence the outcome of an event.
- Account holder and or people associated with the Account holder are directly or indirectly avoiding the rules of the Website.
- The result of an event has been directly or indirectly affected by criminal activity.
- The odds of an event have significantly been changed due to a public announcement in relation to the event.
- Bets have been placed that would not have been accepted otherwise, but they were accepted during periods when the Website has been affected by technical problems.
- Due to an error, such as a mistake, misprint, technical error, human error, force majeure, or otherwise, bets have been offered, placed, and or accepted due to this error.

6.3. When we close or suspend an Account for whatever reason, we reserve the right to close any future Accounts that may be registered by the same person, device, or address, or that may use the same payment wallets or credit cards and void/cancel all transactions of that Accounts.

6.4. We offer two-factor authentication (2FA) as additional protection from unauthorized use of your Account. You are responsible for keeping your login information confidential and making sure it cannot be accessed by another person.

6.5. By registering the Account on the Website you undertake, declare, and warrant that:

- You are over 18 years of age, or such higher minimum legal age of majority as stipulated in the laws of jurisdiction applicable to you and, under the laws applicable to you, you are allowed to participate in the Games offered on the Website.
- You will use this Website and your Account solely and exclusively for the purpose of your genuine participation in the Games and not for any financial or other operations; your participation in the Games will be strictly in your personal non-professional capacity for recreational and entertainment reasons only.
- You participate in the Games on your own behalf and not on behalf of any other person.

6.5.1. You are solely responsible for reporting and accounting for any taxes applicable to you under relevant laws for any winnings that you receive from the Website.

6.5.2. All money that you deposit into your Account is not tainted with any illegality and, in particular, does not originate from any illegal activity or source.

6.5.3. You understand that by participating in the Games you take the risk of losing money deposited into your Account.

6.5.4. You should not be involved in any fraudulent, collusive, fixing, or other unlawful activity in relation to your or third parties' participation in any of the Games and shall not use any software-assisted methods or techniques or hardware devices for your participation in any of the Games. The Company hereby reserves the right to invalidate or close your Account or invalidate your participation in a Game in the event of such behavior.

6.5.5. Concerning deposits and withdrawals of funds into and from your Account, you shall only use credit cards and other financial instruments that are valid and lawfully belong to you.

6.5.6. The computer software that we make available to you is owned by the Company or other third Parties and is protected by copyright and other intellectual property laws. You may only use the software for your own personal, recreational uses in accordance with all rules, terms, and conditions hereby established and in accordance with all applicable laws, rules, and regulations.

6.5.7. Games played on the Website should be played in the same manner as games played in any other setting. You shall be courteous to other players and representatives of the Company and shall avoid rude or obscene comments, including in chat rooms.

7. DUPLICATE ACCOUNTS

7.1. Our Website allows you to open and use only one account per person/device/household/family.

7.2. Only one Account for each household, IP address, and computer or device is allowed. If two or more users share the same household, IP address, and computer or device we must be informed by the respective Accounts' holders in advance.

7.3. If this rule is violated, the accounts will be marked as duplicates (hereinafter Duplicate Account). The Company has the right to immediately delete any Duplicate Accounts and, AT ITS OWN DISCRETION:

7.4.1 deem invalid any transactions made from the Duplicate Account;

7.4.2 refund all bets and deposits made from the Duplicate Account, minus the withdrawn funds and any Company commissions for the associated financial transactions;

7.4.3 void any refunds, winnings, and bonuses that you have received or collected while using an active Duplicate Account. You agree to return to us any such funds that have been withdrawn from the Duplicate Account upon our request.

8. DEPOSITS

8.1. To have the possibility to place deposits and play for real money you must deposit money into your Account. You can deposit at any time online by using your debit or credit card, e-wallet, via a bank transfer or via all available deposit methods. All available deposit methods can be found on the "Deposit page" on the Website. Cash or cheques are not an accepted method of deposit. Please note that some of the methods may not be available in some countries.

8.2. We accept payments in various currencies. Any payment received by the Company in a currency other than the currency of your Account will be converted into the currency of your Account, at the prevailing exchange rate. Please note that any exchange premiums are payable by you.

- 8.3. The Company reserves the right to use additional procedures and means to verify your identity (KYC) when effecting deposits into an Account and to close an Account if you fail to send these documents to the Company.
- 8.4. The Company does not grant any credit for the use of its services.
- 8.5. By depositing you confirm that all deposits are authorized, and you won't try to decline them or take any action that will cause such payment to be reversed by the third party, in order to avoid any legitimate liability.
- 8.6. As a prevention of money laundering, a deposit must be wagered at least once before a withdrawal can be made. Please note that you must complete the wagering requirements before submitting a withdrawal request.
- 8.7. The Company doesn't allow making 3rd party deposits (by a friend, relative, partner, wife, or husband). All payments must be made from an Account/system or credit card that is registered on the Account holder. If the 3rd party deposits are noticed all winnings will be forfeited and sent back to us, and the deposit will be returned to the rightful owner of an Account/credit card. If a banking transfer requires a charge while returning money back to the rightful owner, it will be paid by a receiver.
- 8.8. We reserve the right to use third-party organizations to process electronic transactions, including payments made by and to you.
- 8.9. In case we discover any fraudulent transactions on your part, including the use of stolen credit cards, any payment refunds or cancellations, and actions related to funds deposition for the purpose of exchange between payment systems, the Company reserves the right to block your Account, cancel any payments made and revoke any winnings. We reserve the right to notify the relevant authorities about any fraudulent or illegal activity.
- 8.10. The company is not responsible for any unauthorized credit card activity.
- 8.11. You agree and understand that your account is not a banking account, which means there aren't any deposit insurance guarantees or any other types of banking insurance guarantees. Additionally, no interest is accrued on the account.
- 8.12. The use of the One-click feature to make a deposit by the Client. By making the first deposit using the 1-Click feature on the Website and successfully completing the 3DS authentication (a procedure that confirms that the transaction is made with the cardholder's consent), the customer agrees to subsequent 1-Click transactions using this bank card (with no further 3DS authentication required).

9. PAYOUTS

- 9.1. When the outcome of a Game you participate in becomes determined or, where applicable, the Company has confirmed the relevant result of an event and settled the markets; all winnings will be available on your Account.
- 9.2. If the Company mistakenly credits your Account with winnings that do not belong to you, whether due to a technical or human error or otherwise, the amount will remain the property of the Company and the amount will be deducted from your Account. If prior to Company becoming aware of the error you have withdrawn funds that do not belong to you, without prejudice to other remedies and actions that may be available at law, the mistakenly paid amount will constitute a debt owed by you to the Company. In the event of an incorrect crediting, you are obliged to notify the Company immediately.

10. WITHDRAWALS

- 10.1. You have the right to request fund withdrawals from your account, provided that all payments made to your account have been checked and met all criteria of the Terms above.
- 10.2. Before making any payments, the Company has the right to request copies of identity documents from the Client. The Company adheres to the international KYC guideline (Know Your Customer), which obliges companies to conduct identity checks on their clients before allowing any withdrawal operations. The Company reserves the right to require the Client to undergo additional identity verification methods, including, but not limited to, video identification, a request for a snapshot of the person's face next to their identity document, etc.
- 10.3. You must provide your KYC documents, and credit card pictures (both sides, front and back. The card number should be with the first 6 and last 4 digits of the card clearly readable, while the remaining digits of the card number and CVV / CVC code should not be visible) and bank statement, copy of a personal identification document, proof of address, proof of ownership of any other used payment method when claiming the withdrawal for the first time. Additional requirements depending on payment channels will apply.
- 10.4. The Company reserves the right, without prior notice, to deny the Client access to the services of the Website and to block the game account with the cancellation of all winnings, if, from the moment of requesting additional information, the Client doesn't provide the requested data within 30 calendar days.
- 10.5. The Company reserves the right to change the maximum allowed sum for each payment system per transaction at any time and without prior notification.
- 10.6. A withdrawal request will not be processed until all wagering requirements have been met.
- 10.7. It will not be possible to withdraw funds marked as "Bonus", as well as funds stuck in an aborted game.
- 10.8. At the moment of requesting a payment, your Bonus Balance should have no active bonuses, gift boxes, or free spins. Otherwise, the Company reserves the right to cancel any active bonuses and winnings on them when processing the payment.
- 10.9. If at the time a withdrawal request is made the sum of all bets placed by the Client is lower than the sum of all their deposits, the website administration has the right to withhold up to 20% of the amount requested for withdrawal. If the Client wants to withdraw funds using a bank card, we reserve the right to withhold up to 25% of the amount requested for withdrawal.
- 10.10. If at the time a withdrawal request is made, the sum of all bets placed after the most recent deposit is less than the most recent deposit amount, the website administration has the right to withhold up to 20% of the amount requested for withdrawal. If the Client wants to withdraw funds using a bank card, we reserve the right to withhold up to 25% of the amount requested for withdrawal.
- 10.11. The company reserves the right to check and analyze any of your financial transactions within a period of up to 24 hours prior to fulfilling the requested withdrawal.
- 10.12. A withdrawal request may remain unprocessed beyond the indicated processing times for technical reasons and/or due to any delays caused by the payment system handling the transaction.
- 10.13. A user cannot withdraw funds in excess of his/her Account balance.

10.14. Withdrawals will be made to your bank account or other withdrawal methods available to you in “Cashier”. The withdrawals are processed by the method used by the user to deposit funds into the Account balance.

10.15. Your bank issuer may charge an additional fee for transferring and processing funds.

10.16. When a withdrawal is canceled, the funds are returned back to your Account, and you can make use of those funds accordingly on the Account. The Company does not assume any responsibility for any funds lost during gameplay following a withdrawal cancellation either by you or by us.

10.17. Please be advised that our products are consumed instantly during gameplay. Thus, we cannot provide refunds, returns of monies, or cancellation of the requested service when playing. If you play a Game with real money, the money will be drawn from your Account instantly.

10.18. You may request withdrawals up to approximately €4,500 per day (or the equivalent in your account currency). For VIP clients, higher limits may be granted upon request and at the discretion of the risk management team.

10.19. There is no fixed monthly withdrawal limit. However, based on the daily limit of €4,500, an approximate monthly withdrawal total of up to €135,000 may be possible.

10.20. You can only have one pending withdrawal (i.e. requested but not processed) per payment method at any one time. Furthermore, depending on the method used, you can make only one withdrawal request per 24-hour period.

11 ACCOUNT CLOSURE

11.1 You may close your Account at any time and request a withdrawal of the balance of the Account, subject to the deduction of relevant withdrawal charges. To close your Account, you must first cancel any open bets if applicable and contact the Website customer support - support@pin-up.support.

11.2 The effective closure of the Account will correspond to termination of your relationship with the Company.

11.3 In case the reason behind the closure of the Account is related to concerns about possible gambling addiction you shall contact: responsiblegaming@pinup.contact.

11.4 The method of repayment will be at our absolute discretion.

11.5 The Company reserves the right to close your Account and to refund to you the "Available to withdrawal" balance, subject to the deduction of relevant withdrawal charges, at Company's absolute discretion and without any obligation to state a reason or give prior notice.

11.6 The Company reserves the right to cancel and remove any bonus amount awarded to you if not been used within 1 month from the date awarded.

11.7 The Company reserves the right to refuse a withdrawal claim in case of fraud, in which case an Account will be suspended and the payment not processed.

11.8 The Company will review all player Accounts and classify them at its discretion. Once a player is classified as a “bonus hunter” or “bonus abuser”, all winnings and bonuses will be void and the Account will be suspended and the payment not processed.

11.9 Under these Terms, once your account is terminated, both you and the Company will no longer have any further obligations toward each other.

11.10 The Company reserves the right to terminate your account and remove associated credentials, including your username and password, without prior notice under the following circumstances:

11.10.1 Your account is connected to another account that was previously deleted.

11.10.2 Your account is associated with a currently blocked account. In such cases, we have the right to close your account regardless of how the connection was established. Additionally, we may restrict access to the credentials of related accounts. Any remaining balance will be refunded to you within the designated timeframe after any outstanding debts to the Company are settled, except where otherwise stated in these Terms.

11.10.3 You engage in hacking attempts or collude with others to manipulate outcomes.

11.10.4 You interfere with the Website's software or alter its functionality in any way.

11.10.5 Your account is used for unlawful activities, including attempting to access the Website from a jurisdiction where gambling is prohibited.

11.10.6 You post offensive, abusive, or inappropriate content on the Website.

11.10.7 You breach the Terms on the Website.

11.11 In cases where the Company decides to terminate your account, we will notify you via email using the contact details provided in your account. If the account closure is not related to violations of the AML Policy or other breaches of these Terms, any remaining balance will be refunded to you.

11.12 If you do not log in to your Client Account for 180 consecutive days, it will be classified as an inactive account. We will notify you via email at least 30 days before your account becomes inactive.

11.13 Once an account is deemed inactive, the remaining balance will be debited from the account.

11.14 Following your account becoming inactive, we will suspend the account at that time for security reasons. This means that following your request and following our completion of any identity verification checks we need to undertake, we will restore access to your account. Funds that were debited due to the account suspension are not subject to refund.

12 PERSONAL INFORMATION

12.1 We will comply with applicable data protection laws in respect of the personal information you supply to us. Your personal information is processed in accordance with our Privacy Policy, a copy of which is available by clicking [here](#).

13 PROHIBITED ACTIONS ON THE WEBSITE

13.1 In the case when any irregularity (including suspicion of attempted money laundering or fraud) has been noticed, the Company reserves the right to close Accounts and/or report criminal, or other suspicious activities provided through one or multiple Accounts to the relevant existing regulatory or law enforcement authorities. All offenders' Account balances will be blocked, withdrawals will be void, and deposits and winnings will be forfeited.

13.2 The Company is eligible to disable users' Accounts and forfeit their Account balances (including deposits and winnings) if they are noticed of gaining or attempting to gain an advantage of trading information of their cards or establishing a collusive agreement with other users to take an unfair advantage. These advantages may consist of chip dumping and transfer, discussing a hand during play, multiple using a single Account, and soft playing. The Company provides the rigorous examination of

play in both manual and automated ways and investigates all related user complaints. In addition, Company provides proactively and randomly examining gameplays and Accounts.

13.3 Once Company noticed a fraudulent, unlawful, dishonest, or improper activity (including using the VPN, proxy, or similar service that masks or manipulates the identification of your real location, or making wagers or poker play through a third party or on behalf of a third party) on the Website, we are eligible to block user's Account with forfeiting of all Account balances without prior notification. In such cases, Company reserves the right to report fraudulent activity to existing regulatory and law enforcement authorities including but not limited to banks, credit card companies, and/or any person or entity that has the legal right to such information, and/or taking legal action against such user.

13.4 Uploading a volume of information to the Website that may cause disruptions, as well as performing any activities that may affect the Website's performance, such as using and/or distributing viruses or similar malware, are prohibited.

13.5 Distortion, deletion, or any other alteration of the Website's data are prohibited.

13.6 You agree not to use any hacking and/or similar methods to bypass the Website security. In case our security system gets breached, we will be forced to immediately stop your access to the Website services and block your Account. The Company reserves the right to inform any relevant authorities of such events.

13.7 Gaining unfair advantage (commonly known as cheating) is not allowed. This includes using any malware, exploiting errors and loopholes in our software, and using automated players, known as bots.

13.8 Colluding or attempting to directly or indirectly collude with other players is not allowed during your use of the Website.

13.9 We will take all reasonable steps to prevent such activities, detect any collusions and all involved players, and deal with them accordingly. We will not be liable for any losses or damage which you or any other player may have suffered as a result of collusive, fraudulent, or otherwise illegal activities and/or cheating. Any action we take against any involved parties will be at our sole discretion.
