

KYC Policies

1. What is KYC? This is a very simple process of verifying your identity to enable us process your winnings. In line with Betting Company regulations, all customers at the request of the Betting Company are required to provide a valid means of identification before winnings can be paid out.

Any of the following documents will accepted:

National Identity card / slip

Driver's license

International passport

The document must contain a photograph and should clearly display your full name, date of birth and have a valid document expiry date. Please note, if your ID document has an expiry date on the back, it should also be scanned and sent to us.

Our support team will review your details within a few hours and revert once your details have been updated. If more info is required from you, you will also be notified.

2. Privacy Policy. Bittech B.V. ("Bittech B.V. ", "The Betting Company", "We") values your Personal Data and we are committed to protecting your privacy whenever you interact with us. Please read this Privacy Notice (Notice) to understand our policies, processes and procedures regarding the processing of your personal data.

By this Notice, We explain to you how your Personal Data is collected, used, managed and transferred by Bittech B.V. and also explains how you can update your Personal Data with us and exercise your rights in respect of the Personal Data provided to us.

3. The Personal Data that We Collect. We collect Personal Data that you give to us, for example, where you create an account with us, request for further information about our product, fill a form, apply for a job through our website or you subscribe to newsletters on our website.

We may also automatically collect some technical information when you visit our website such as your IP address, and information about your visit, such as the pages that you viewed. This information helps us understand customer interests and helps us improve our website. When you visit our site, the pages that you look at, and a short text file called a cookie, are downloaded to your computer. By visiting and using our website, you agree to our use of cookies in line with Betting Company's policies.

4. What Purpose do We use your Personal Data? We may process your Personal Data to communicate with you (including sending marketing or promotional materials to you), provide you with further information about our products and how we can serve you better, respond to your purchase orders or requests, and process your application for employment with

Betting Company or to fulfil our contractual obligations with you. We may also process your Personal Data to comply with provisions of applicable laws.

5. What Constitutes your Consent? Where processing of Personal Data is based on consent, We shall obtain the requisite consent at the time of collection of the Personal Data. In this regard, you consent to the processing of your Personal Data when you access our platforms, or use our services, content, features, technologies or functions offered on our website or other digital platforms. You can withdraw your consent at any time but such withdrawal will not affect the lawfulness of processing based on consent given before its withdrawal.
6. Who do we share your Personal Data with? We respect your privacy and we limit disclosure of your Personal Data to third parties. We do not sell, give or trade any Personal Data that We obtain from you to any third party for data-mining or marketing purposes. However, We may share your Personal Data with service providers engaged by us to provide services to Betting Company subject to appropriate data security and protection. We may also share your information where there is a regulatory or statutory obligation to disclose such Personal Data in accordance with provisions of applicable laws.
7. Security and Retention of your Personal Data. Your Personal Data is kept private and We make every effort to keep your Personal Data secure, including restricting access to your Personal Data with us on a need to know basis. We require our staff and any third parties who carry out any work on our behalf to comply with appropriate security standards to protect your Personal Data.
We take appropriate measures to ensure that your Personal Data is only processed for the minimum period necessary in line with the purposes set out in this Notice or as required by applicable laws, until a time it is no longer required or has no use. Once your Personal Data is no longer required, We destroy it in a safe and secure manner.
8. Your Rights. Betting Company collects Personal Data only for the purposes identified in this Policy and such information cannot be reused for another purpose that is incompatible with the original purpose. You can exercise the following rights with respect to your Personal Data with Betting Company: request for and access your Personal Data collected and stored by Betting Company
 - withdraw consent at any time. For example, you can withdraw your consent to receipt of our marketing or promotional materials or unsubscribe to our newsletters;
 - object to automated decision making;
 - request rectification and modification of Personal Data kept by Betting Company; request for deletion of your Personal Data;

- be informed of and entitled to provide consent prior to the processing of Personal Data for purposes other than that for which the Personal Data were collected;
 - request that Betting Company restricts processing of your Personal Data; and request for information regarding any specific processing of your personal data.
9. Changes to our Privacy Notice. Due to constant changes in technology and regulatory requirements, we may need to change our privacy policies or update this Notice from time to time. You will always be able to find the most recent version of our updated privacy policy on this site.

11. Use of Personal Data

In accordance with the requirements of the applicable law, the Client entering into this Agreement provides the Betting Company with the right and gives its consent with:

- processing by the Betting Company of its Personal Data specified by the Client at the time of registration, as well as the data provided by the Client later on at request of the Betting Company to verify the compliance with the internal requirements of the Betting Company, provided that their processing is carried out by an authorized person who took the obligation of keeping the specified information confidential;
- taking by the Betting Company of any actions (operations) with its Personal Data, including data collection, classification, accumulation, storage, updating, modification, use, depersonalization, blocking, destruction and cross-border transfers, including with the use of automation facilities;
- processing by the Betting Company of its personal data by entering them into an electronic database, lists (registers) and report forms. Processing of the Personal Data is performed by the Betting Company subject to the requirements of current legislation and using the following main ways (but not limited to): storage, recording on digital media and storage, inventories, marking. The rights referred to in para. 7.1 of this Regulations, shall be provided by the Client to the Betting Company until the expiry date of the relevant information or documents containing the above information, as defined in accordance with applicable law, and if they are revoked the processing of personal data of the Client must be terminated by the Betting Company and/or by third parties and is destroyed if the Agreement is terminated not later than one (1) year from the date of determination of the Agreement. The rights referred to in para. 7.1 of this Regulation, shall be

provided by the Client to the Betting Company for the purpose of execution of the requirements of the applicable law, and for the purposes of conclusion by the Client of any agreements with the Betting Company, and their future performance, as well as for the purpose of making by the Betting Company of decisions or carrying on of other activities that give rise to legal consequences with regard to the Client, and for the purpose of provision of the Client with information about the services provided by the Betting Company, and are applicable to the Personal Data.
