

SUPPLEMENTAL AGREEMENT NO. 1

to the Software and Services License Agreement dated December 1, 2022

This SUPPLEMENTAL AGREEMENT is made on **November 15, 2023** by and between:

HIGHFLIER B.V., a legal entity registered in Curacao under company number 149996, with its registered office at Dr. H. Fergusonweg 1, Curacao (hereinafter referred to as the "**Licensor**"), on the one side; and

BITTECH B.V., a legal entity registered in Curacao under company number 153870, with its registered office at Dr. M.J. Hugenholtzweg 25 Unit 11, Curacao (hereinafter referred to as the "**Licensee**"), on the other side.

The Licensor and the Licensee are hereinafter separately referred to as the "**Party**" and jointly as the "**Parties**".

WHEREAS, the Parties have entered into the Software and Services License Agreement dated December 1, 2022 (the "**Agreement**"),

AND WHEREAS, the Parties now wish to amend the Agreement pursuant to the terms and conditions set forth herein,

IT IS HEREBY AGREED as follows:

1. To add **Appendix D "Special terms and conditions related to GPTwin.bet Website"** to the Agreement as indicated in Appendix to this Supplemental Agreement.
2. To add the following provisions to **Clause 1 of the Appendix B** to the Agreement with effect as of November 1, 2023:

"The Reduced/Increased percentage of GGR shall take effect on the first date of the month following for the previous reporting month.

Columns 2 and 3 of the table above are set out the conditions under which the percentage of GGR depends on the GGR value, which is specified as a threshold."

3. **Effect of this Supplemental Agreement.** The Agreement, together with this Supplemental Agreement, shall be read and construed as one document and any references to the Agreement shall from the date hereof incorporate references to this Supplemental Agreement.
4. **Electronic Acceptance.** This Supplemental Agreement may be concluded in electronic form (e.g., by an electronic or digital signature or other means of demonstrating assent) and will be binding between the Parties. Both Parties agree that it will not contest the validity or enforceability of this Supplemental Agreement because it was concluded in electronic form. The copy of this Supplemental Agreement and all documents attached to it, acts signed by the Parties, scanned or signed in electronic form or using the electronic means of signing and transmitted by email, have the legal force of the original. The exchange of documents, messages, as well as the conditions, requirements agreed in the course of correspondence in messengers, email can serve as evidence in the event of disputes. Documents received or sent in this way, the email itself, has equal legal force as well as the original written document.

APPENDIX D TO THE SOFTWARE AND SERVICES LICENCE AGREEMENT

This Appendix D "Special terms and conditions related to GPTwin.bet Website" is made on November 15, 2023 by and between:

HIGHFLIER B.V., a legal entity registered in Curacao under company number 149996, with its registered office at Dr. H. Fergusonweg 1, Curacao (hereinafter referred to as the "**Licensor**"), on the one side; and

BITTECH B.V., a legal entity registered in Curacao under company number 153870, with its registered office at Dr. M.J. Hugenholtzweg 25 Unit 11, Curacao (hereinafter referred to as the "**Licensee**"), on the other side.

WHEREAS, the Licensee is engaged in business operations through the GPTwin.bet Website, and

WHEREAS, the Licensee is willing to use the Software (namely, Sportsbook module) on GPTwin.bet Website,

the Parties have agreed on the following fees related to business operations through the GPTwin.bet Website.

1. Monthly Fees.

In consideration for the Services provided and license granted to Licensee under this Agreement, Licensor shall be entitled to receive every month from the Licensee a fee in EUR from GGR that the Licensee has received from its business operations through the GPTwin.bet Website in the current month in the amount of:

NOTES:

- The Reduced/Increased percentage of GGR shall take effect on the first date of the month following for the previous reporting month.
- Columns 2 and 3 of the table above are set out the conditions under which the percentage of GGR depends on the GGR value, which is specified as a threshold.

2. Minimum Monthly Fee. In consideration for the Services provided and license granted to Licensee under this Agreement, the Licensor shall be entitled to receive every month from the Licensee the Minimum Monthly Fee which should be paid by the Licensee regardless of the appropriate GGR level results for business operations through the GPTwin.bet Website in the amount of:

The Minimum Monthly Fee is calculated starting from the Go-Live Date related to the GPTwin.bet Website.

3. Setup Fee. The Licensee shall pay a non-refundable fee to the Licensor for the setup of the Software (namely, Sportsbook module) on the GPTwin.bet Website in the amount of **EUR 5.000**.

The Setup Fee shall be paid within 5 (five) business days from the date of signing of this Appendix.

4. The Licensor shall reserve the right to unilaterally amend Clause 1 or Clause 2 of this Appendix upon expiration

of one-year period from the Go-Live Date related to the GPTwin.bet Website.
