

ADDENDUM No.2

to the Supply and Services Agreement between Agreegain Limited and Great Star NV dated the 1st October 2024

Parties

- (1) Agreegain Limited incorporated and registered in the Isle of Man with company number 136883C whose registered office is at First Floor, Cycle 360 House, Isle of Man Business Park, Douglas, IM2 2QZ (**Agreegain**)
- (2) Great Star NV incorporated and registered in Curacao with company number 122623 whose registered office is at Schout bij Nacht Doormanweg 40, Damacor Offices, Willemstad, Curacao (**Operator**)

Background

This Addendum becomes effective on 1 October 2025 ("**Effective Date**") and constitutes an addition to the Supply and Services Agreement between Agreegain and Operator originally executed on the 1st October 2024 (as amended) (the **Agreement**) to add additional Games to the Right to Supply under the Agreement as indicated in bold type below

Terms

1. As of the Effective Date of this Addendum, the parties agree to delete and replace clause 1 and 2 of Schedule 1 (Fees) (as amended) as follows:

1. Supply Fee

- 1.2. The Supply Fee which is payable by the Operator to Agreegain in accordance with Clause 7 is calculated as a percentage of the Operator's monthly Gross Gaming Revenue (Stakes - Winnings). The GGR is payable by the Operator to Agreegain as follows:

Corresponding pricing information will be made available to the Operator. The Operator will be entitled to accept or refuse the use of the additional Games, Tools and/or Third Party Suppliers.

2. For the avoidance of doubt, Clause 2 (Platform Fee) of the Agreement is deleted and shall have no force or effect.

3. As of the Effective Date of this Addendum, the parties agree to add the following Definitions to Section 1.1 of the Agreement:

"Bonus: a promotional amount as may be offered, applied and determined by Third Party Supplier(s) and then gifted by the Operator on its terms and conditions to an End Users for the purposes of placing Stakes.

Bonus Profit: any profit derived by the Operator from End User's activity using Bonus Money, which shall be calculated as Bonus Stakes minus Bonus Winnings.

Bonus Stakes: Stakes that are derived solely from Bonus Money.

Bonus Tool(s): a feature(s) which allows the Operator to create, manage and control the promotional campaign rules that can trigger an award of Bonus Money to End Users and which has been integrated into, tested and used with the Agreegain Platform.

Bonus Winnings: Winnings that are derived solely from Bonus Stakes."

3. As of the Effective Date of this Addendum, the parties agree to add the following Schedule IV to the Agreement:

“Schedule IV

THIRD PARTY TERMS

The Operator shall at all times comply with the terms, conditions, and requirements set out in this schedule ("Third-Party Terms"). The Operator is responsible for ensuring that its activities in the Agreement, do not cause any breach of the Third-Party Terms. Any failure by the Operator to comply with the Third-Party Terms shall constitute a breach of this Agreement.

The Operator agrees that Agreegain may revise the Third-Party Terms from time to time, and the Operator shall remain compliant with all current versions.

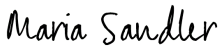
