If this document is to be used in a country which is not party to the Hague Convention of 5 October 1961 it should be presented to the consular section of the mission representing that country.

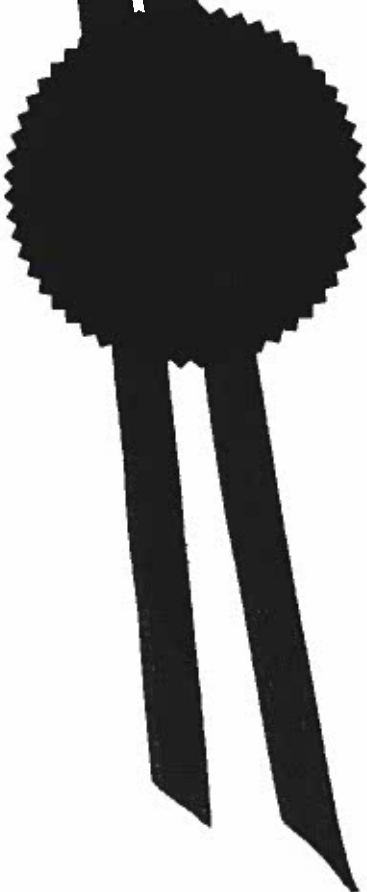
