

DEED OF TRANSFER OF SHARES AGREEMENT

THIS DEED OF TRANSFER OF SHARES AGREEMENT ("DTSA" or "Agreement") is made on January 3, 2024 by and between:

1. **Anastasiia Pankova**, an individual born in Ukraine, on October 6, 1993, holder of passport FZ2502984, residing at Region Kharkivska, district Kharkivskiy, village Lyptsi, St. Pushkinska, Bulding 4, fl. 9, Ukraine. (the **"Transferor"**);

and
2. **Arman Magoyan** an individual, born on July 8, 1980 in the Republic of Armenia, holder of a passport number AU0541133, residing at Vanadzor City, Rustavi Street, House 3, apt. 2, Republic of Armenia (the **"Transferee"**);

WHEREAS:

At present, the Transferor is the shareholder of 500 shares, of USD 10 each, representing entire issued and paid-up nominal capital (hereinafter the **"Shares"**); of the Company **FUN FUSION N.V.** a limited liability company incorporated under the laws of Curaçao, and having its registered office at Abraham de Veerstraat 9, Willemstad, Curaçao, registered with the Commercial Register of the Curaçao Chamber of Commerce & Industry under number 156583 (the **"COMPANY"**);

The Transferor wishes to transfer 500 shares in kind to the Transferee and the Transferee wishes to acquire the Shares subject to the terms and conditions of this Agreement;

NOW, THEREFORE, IT IS HEREBY AGREED as follows:

Transfer of the Shares

The transferor transfers unto the transferee 500 shares, of USD 10 each, representing the entire issued and paid-up nominal capital of the Company registered in the name of the Transferor.

The transfer of the Shares as referred herein shall take place by the execution of this Agreement and the written acknowledgement thereof by the Company, which acknowledgement shall be annotated on this Agreement.

Counterparts

This Agreement may be executed in one or more counterparts or on one or more signature pages, each of which shall be deemed an original, but all of which together shall **constitute one and the same instrument**.

Governing law and place of jurisdiction

This Agreement shall be governed by the laws of Curaçao and in case of a dispute, the Lower Court of Curaçao will be competent.

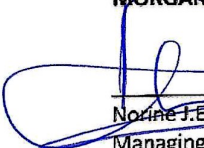
