Description English	1a. to organize, market, promote, manage and operate all types of remote gaming activities and sports betting activities, comprising all types of games, betting transactions, the operation of betting exchanges, interactive casinos, bingos, lotteries and other interactive games and to carry out any activities ancillary thereto by offering goods or services to persons who participate in licensed online gaming; b. to act as buyers, sellers, either by wholesale or retail or correspondence, promoters, importers, exporters, bailees, commission merchants and commission agents and brokers in respect of all types of plants, machinery, equipment, merchandise, goods, products and raw materials without restriction as to type or volume, and whether for immediate or future delivery, and whether on a cash or margin basis, in particular software and hardware required in the electronic gaming business; c. to purchase or otherwise acquire and import equipment required by the corporation in order to carry out its objects; d. to invest its resources in securities such as shares and other certificates of participation, in bonds and other interest bearing claims for debts under whatever name and in whatever form, to borrow money and to issue certificates of indebtedness therefore, as well as to lend money and to provide security in any form for the benefit of the corporation as well as for the benefit of third parties; e. to acquire: (i) returns, resulting from the alienation or granting of the right to make use of copyrights, patents, models, secret processes or formulas, trade marks and other such things; (ii) royalties, including rents with regard to films or the use of industrial, commercial or scientific installations and with regard to the exploitation of any mine or quarry or any other natural resources and other immovables; (iii) remuneration for the rendering of technical assistance; f. to acquire, possess, alienate, manage and develop real estate and/or any right to or interest in real estate, and to participate in any other enterprise or corporation with similar or related objects; g. to lease, mortgage or in general to encumber real estate and any right thereto or interest therein; h. the trade including wholesale trade, intermediate trade and future trade in as well as the import and export of raw materials, minerals, metals, organic matter, semi products and finished products of any nature and under any name; i. to participate in and to manage enterprises and corporations; 2. The corporation is authorized to perform everything requisite or profitable to the accomplishment of its purpose or incidental thereto or connected therewith in the widest sense of the word. 3. The corporation has no authority to invoke the annulment of legal acts



performed by the corporation, which exceed the corporate objective.
