This authorization is effective immediately and shall remain effective until a letter of termination is issued by the Legal Representative to the GCB, and which termination the GCB is satisfied has been made by a person which then has due legal authority to bind the Applicant Company. Once a license is issued the Authorized Representative’s rights shall also cease automatically.

The GCB will notify the Legal Representative if it deems the Authorized Representative to be unsuitable. The Legal Representative will promptly terminate this Letter of Authority and appoint an alternate Authorised Representative.
