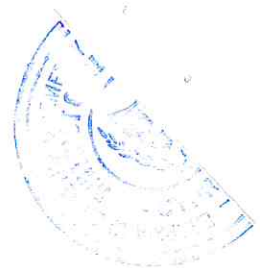

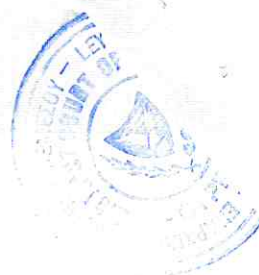

I take this opportunity to offer my congratulations on your appointment and my wishes for every success in your future work.

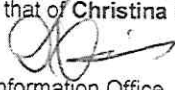
