the Founder informed the Board Member of the Foundation of its intentions and further requested the Board Member to sign this resolution as formal acknowledgment hereof.

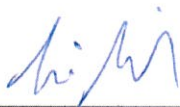
DO HEREBY ADOPT the following resolutions:
