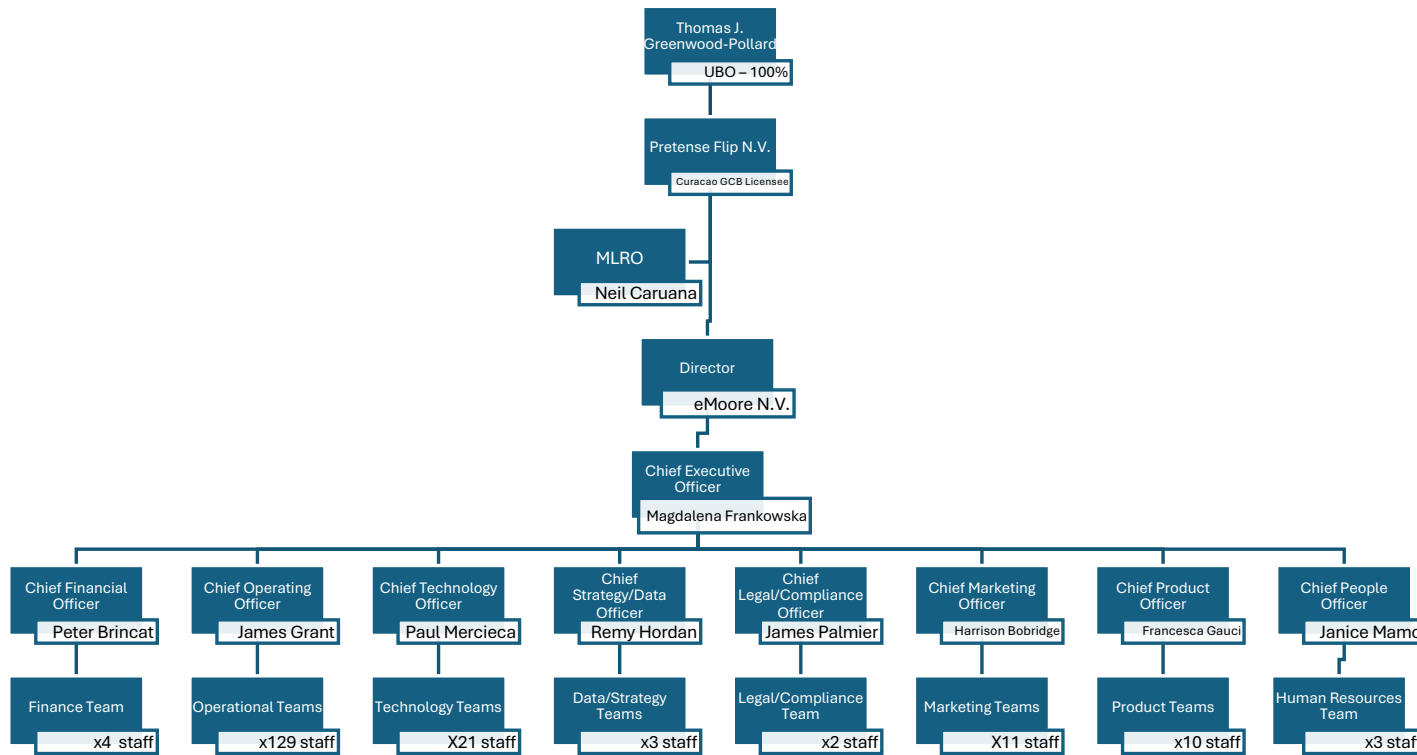

1. Ultimate Beneficial Owner (UBO)
