The purpose of the corporation shall be: a. to organize, market, promote, manage, support and operate all types of remote gaming activities, comprising all types of games of skill and chance, betting and other operation of betting exchange, interactive casinos, bingos and other interactive games; b. to perform marketing activities for the account of the corporation itself and for the account of other corporations; c. to incorporate, to participate in any way whatsoever, to manage, to supervise, to operate and to promote enterprises, businesses, companies and other legal entities; d. to finance businesses, companies and other legal entities; e. to borrow, to lend and to raise funds, including the issue of bonds, promissory notes or other securities or evidence of indebtedness as well as to enter into agreements in connection with the aforementioned. f. to supply advice and to render services to enterprises, companies and other legal entities with which the corporation forms a group and to third parties; g. to grant guarantees, to bind the corporation and to pledge its assets for obligations of the enterprises, companies and other legal entities with which it forms a group and on behalf of third parties; h. to acquire, encumber, manage, lease, exploit and finance registered property and items of property in general and to exploit, administrate and exercise all rights attached to registered property and items of property in general; i. to trade in currencies, securities and items of property in general; j. to develop and trade in patent, trademarks, licenses, know-how and other industrial property rights; and k. to perform any and all activity of industrial, financial or commercial nature. 2. The corporation is authorized to perform everything
