Article 4

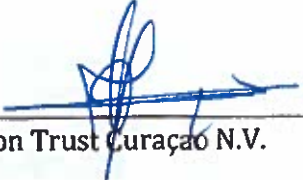
Purchaser is irrevocably authorized by the seller to take any necessary action to effectuate the transfer of the Shares to the purchaser.
