In case of doubt about the authenticity of this document, you can perform the following checks:

Properly check the front page of the document

You see a pattern of grey hexagons.
In between extremely small text is printed in green and orange: under a magnifying glass this text must be neat and sharp.
For that matter, the latter also applies to all other lines and patterns in the document.
In addition, the paper has fibers in several colors.

Hold the document up to the light

The paper contains the registered CIB watermark throughout in the form of a stylistic honeycomb.

Make a photocopy

If you make a photocopy of an authentic document, the grey hexagons will contain the text COPY – KOPIE.

Use a UV light

Under UV light, small green and blue fibers become visible as well as fibers that light up in three of four colors. The orange print in the middle of the document lights up in yellow. In addition, the number of the document at the bottom right lights up in green / yellow.

Unique numbering

The unique number at the bottom right is printed with letterpress printing. During the printing, the ink is pressed outwards. This results in so-called beaded edges that are visible under a magnifying glass.

Is the text COPY – KOPIE clearly visible on the front page?

Then you are dealing with a photocopy! You can always perform the checks described above in order to be sure.

Personally making changes or additions is not permitted and renders this document invalid.

The use of false and falsified documents is punishable.
